The meeting was called to order at:1:30 PM

- 1. Introductions were conducted and procedures were discussed.
- 2. Proposed amendments were considered. First a determination of the emergency nature of the proposal was determined and if deemed an emergency the committee considered recommendation. Proposals considered:
 - R1 MSF Motion to consider an emergency
 - R2 MSF Motion to consider an emergency
 - R3 MSA Motion to consider an emergency. Amended proposal to strike "as the recall device." MSA Recommend adoption by the HOD.
 - R4 Withdrawn
 - L4 MSA Motion to accept as a proposal requiring action by more than one committee. MSA recommend adoption by the HOD.
 - U1 MSA recommend adoption by the HOD.
- 3. During recess, the committee formulated and submitted a proposal to the Legislation committee to include USA-Swimming Article 105 as a portion of their rules that USMS automatically follows unless USMS chooses to do otherwise and to provide a method by which the Rules committee can bring to the HOD during a "90%" year changes enacted by USA-Swimming to their facility standards without requiring emergency legislation. The proposed amendment is as follows:

601.4.6 – USA Swimming Amendments That affect USMS Rules

A Amendments to USA Swimming articles 101, "Individual Strokes and Relays," and 102, "Conduct and Officiating of All Swimming Competition," and 105, "Guidelines for Officiating Swimmers with a Disability in USA Swimming," shall automatically be adopted by USMS, unless the USMS House of Delegates votes to reject those amendments. Votes to reject shall not be considered emergency amendments (this action shall take effect immediately).

Amendments to USA Swimming article 103, "Facility Standards" may be recommended by the Rules Committee for adoption by the House of Delegates. Votes to accept shall not be considered emergency amendments.
