NATIONAL OFFICE ADMINISTRATOR Tracy Grilli

Since the last convention (and now for the past 9 years), I have maintained the responsibilities associated with running the USMS National Office.

Before you skip down, you should know that there will be a test at convention. So... if you don't know what Tracy does, you best read it all!!!

National Office Administrator Duties -

- Day to Day duties Responding to e-mail and snail mail, faxes and phone calls. Address Changes
 are constant and these are forwarded to the respective LMSC Registrar as well as to Esther, our
 USMS Database Administrator (more about Esther and registration follows).
- Weekly duties –Publication orders, All American and National Record Certificates. USMS SWIMMER
 Magazine address changes (over 1,000 changes in a registration year) and lots of folding, stuffing,
 licking, sticking and stamping envelopes!

Major Tasks -

- Registration The Registration process is ever-present in some aspect so I can't really list it as a
 daily, weekly or monthly task. It's just "always there". Transmittals come in, Esther maintains the
 database and I'm responsible for the Club registrations & updates and LMSC Officer updates as well
 as the money, reports to the LMSC Registrars & Treasurers and transmittals to our Controller &
 Treasurer.
- National Meet Registration and Verification The National Office has taken on the responsibility of
 inputting the hard copy entries for our 2 national meets, confirming membership, birthdates and club
 affiliations of all who enter. I make the check deposits and create financial reports that are sent on to
 the meet host and USMS Contorller. Over the past year, USMS opened a Merchant Account which
 was used for both meets. The National Office oversees the documentation the transactions.

Other tasks throughout the year -

- Committee Assignments I work closely with the President in setting up the committees.
- Appendix E of the Rule Book I update Appendix E: USMS Directory and sent to the Rule Book Editor
- USMS Directory This is the Directory of "Who's Who" in USMS and it is sent out to all who are in including members of the Board of Directors, Ad Hoc Chairs, Special Assignments, Liaisons, committee members and LMSC Chairmen. Unfortunately we had a "glitch" and the 2005 Directory was not published. There will be one in 2006.
- LMSC Handbook This was developed a number of years ago as a tool to assist the local registrars.
 Over the years many other committees and offices have added important information and the
 handbook now includes the following sections: General Information, Registration, Insurance,
 Sanctions, Top Ten/Records and Tabulations, Long Distance, Treasurer, Marketing/Public Relations,
 Communications, Convention, By Laws, LMSC Management of Corporate Documents and USMS
 Endowment Fund.
- USMS Letterhead and Envelopes The letterhead updated each year and sent along with USMS envelopes to the members of the greater BOD, in the quantities they request.
- Rule Book Sponsors I work with a representative of the Publications Committee, with the invoicing
 of the Sponsors for our Rule Book and sending them copies once they are printed.
- Streamlines... from the National Office This is the quarterly newsletter from the National Office. It includes: USMS Working Calendar (next 4 months), Contact Information Updates (to the Directory,

Rule Book and LMSC Officers), New LMSC Officers and whatever important announcements that will be of interest to our LMSCs and general membership.

- LMSC Officer Update The LMSC Office page on the USMS website has been "revamped" and as the national office receives changes, I update the database on the web so all officer listings are current.
- Convention Registration Packet Once I receive the convention registration information from USAS, I
 "personalize it" for USMS and send it out via e-mail to all in the USMS Directory and those in
 attendance the previous year.
- Convention Packet This is what you are reading!

Yes... it was 9 years ago in Orlando, that I was hired as your Executive Secretary, to run the National Office. My first under the watchful eyes of the Executive Committee of Mel, Jim, Suzanne, Lucy and Stephanie for only a year. It was a year of learning and figuring things out, with Dot Donnelly only a phone call away if I had any questions.

The next 4 years I worked with the administration of Nancy, Jack, Betsy, Jeanne, Hugh and Mel. During this time, I gained valuable experience about all aspects of USMS, became more confident in my knowledge and able to personally respond to members questions (rather than passing them on to someone else in the organization). I also created more efficient procedures, which allowed me to take on more responsibilities – the most obvious was the absorption of the national database administration as a function of the National Office rather than contracting it out.

The past 4 years with the Executive Committee of Jim, Scott, Sally, Doug, Lynn, Nancy and Patty has brought me yet to a higher level as a "voice but no vote" member of the Executive Committee. During this time, I have been included in all EC meetings and conference calls, have gained valuable experience on how the organization is run, how decisions are made, which again allows me to be more knowledgeable and of better assistance to our membership.

The job of Executive Secretary "then" is quite different from the duties of National Office Administrator "now". I now supervise 3 people, 2 employees and 1 contract staff. I work hand and hand (figure of speech, we never see each other) with Esther Lyman, our Database Administrator (and the 53 local registrars) with the registration of our members and member clubs. Esther and I have really fine-tuned this process and look forward to working with other key members of USMS in creating an on-line registration program. Kristin Marchionni has been my office assistant for the past year and she helps with some of the larger "clerical" projects (listed above – you know what they are, right? Remember... there will be a test!) Kristin recently graduated from Londonderry High and just finished her employment with USMS and will be Freshman at Baldwin-Wallace College in Berea, Ohio, studying Communications for Learning Disorders and will be a member of the Yellow Jacket swim team. Mary Lamport has been contracted to process the national meet entries and has done an excellent job performing this duty for our last 4 National meets.

I am in contact some way/some form with all the members of our Board of Directors, Ad Hoc Chairs, Liaisons and Special Assignments along with officers from each LMSC. I look forward to working with the new members of the incoming Executive Committee and Board of Directors who will be elected at this convention in Greensboro.

There have been many changes over the past 9 years with the responsibilities of the USMS National Office. But, the most important duty remains the same and that is - the main contact for those who have questions or need.

DATABASE ADMINISTRATOR Esther Lyman

At this time, the national office has received and booked 2005 memberships with registration dates approximately thru Mid-August. As always, some stragglers dribble in for one reason or another, but it looks like we are back on a decent growth path and may yet make somebody's goal of 43,000 by yearend, or be close.

The registrars have processed 39,425 memberships in 2005, or 94.8% of the 2004 total of 42,130. After deducting for some 60 between-association transfers counted by multiple LMSCs, we have 39,864 net members to date. These are registered with 485 cubs (from a total of 510) within 53 LMSCs. By zone, the breakdown looks as follows:

Note, all the summary numbers of registrations are now captured over the past six (6) years for comparison by month, based on actual registration dates. Please contact the national office if you are interested in seeing the flow of registrations for your LMSC. The breakdown is remarkably similar from year to year, making them extremely valuable for forecasting your association's income during the year.

BY AGE AND SEX

The balance between male/female swimmers has kept changing ever so slightly each year since 1994 when it was about 59.6% male and 40.4% female. But looking at the distribution by decade of birth (=FINA age), the 'average' doesn't really tell us enough, as is evident from the following chart:

LOCATION

Looking at the location (by latest-known mailing address), nothing new there. Of the 39,864 members booked to date (net of transfers), 67.2% reside in the top ten states: California, New York, Florida, Colorado, Texas, Virginia, Illinois, Washington, Massachusetts, and Maryland. Approximately 2/3 as in five prior years. And while Colorado has moved ahead of Texas, the ten remain the same.

CMS is the former RMS, Rocky Mountain Masters. For the record we currently show 4,332 UNAT swimmers, but this status of course is somewhat transitional. Congratulations are in order to SLAM which just passed the 300 mark for the first time, earning them another convention delegate!

Approximately 155,500 individuals have been full members in the program since1994, the earliest year we have electronic files, (including some 7,000+ from earlier years who are listed on the web page with All-American or Top Ten achievements.) Of these about 73,660 or 47.4% have now been assigned permanent ID's – the 'tag' which will follow a swimmer through all memberships, name changes, and locations and is used to manage competitive activities over the past 30-some years.

Welcome to our many new registrars and our appreciation and a sincere thank-you to all the departing ones. We appreciate all the hardy, dedicated registrars who are still with us after another challenging registration year. A special, fond farewell to Kentucky's Joanne Tingley who is (reluctantly) passing the baton after more years than she probably cares to remember.

Next year should be wonderful, as we benefit from all the experiences from this one. Thanks also to those 'other' unsung heroes, the LMSC treasurers, and to the Committee Chairs, and everybody else we work for and support – not the least our master of the black art of registration software development, Leo Letendre and Webmaster Jim Matysek.
