

Why are you interested in this position and why do you believe you would be a good candidate?

The majority of older Americans currently living in Assisted Care Facilities are there, not because of disease, but because of physical frailty. That is a crime! Those of us who enjoy the enormous fitness and fellowship benefits of Masters swimming must dedicate ourselves to "sharing the wealth" by promoting swimming to everyone, of every age and condition. During my 30 years with Masters swimming as an administrator, coach, and competitor I have developed strong local adult swimming and dryland training programs. I have also worked at the National level for 22 years, learning from many other USMS members how to utilize our resources to encourage and motivate adults to improve their lives with Masters swimming.

What do you consider to be the major issues facing USMS now and in the future? As a person holding an elected position within USMS, how would you address these issues?

The issue that first comes to mind is the position of Executive Director. I was very disappointed with the initial selection process, which determined our first Director. It is important, of course, to hire someone with considerable administrative experience, but I believe it is just as critical that they "eat, sleep, and breathe" Masters swimming! In my 30 years with USMS I have met many remarkable people who have accomplished amazing things for this organization. I am adamant that our next Executive Director be someone who has love and enthusiasm for Masters swimming and the desire to move us forward.

Another issue that I believe USMS should vigorously pursue is joint participation activities with other aquatic/athletic organizations such as USA swimming, USA Triathlon, Senior Games, Special Olympics, Paralympics, etc. Although USMS has liaisons or contacts with most of these groups, I believe more should be done at the local level. Many communities have benefited from coordination and consolidation in regards to administration, coaching, securing water time, and training officials.

USMS and USA Swimming could both greatly benefit from a large number of potential swimming officials from USMS members. However, USMS members are required to register separately (and pay additional registration fees) to USA Swimming to be certified. Why do USMS swimmers need a 2nd registration? USMS and USA Swimming are insured by the same company for the same coverage. I will work to help streamline and facilitate training and certification of officials for USMS members.
