- 4. It looks like the Long Course Nationals will be held in Omaha after the Olympic Trials. Erin will be organizing volunteer efforts for Long Course.
- 5. Omaha volunteered to host the Zone meet. Heather moved to approve, Bruce seconded, voting was unanimous in favor of approving. Erin captured potential dates for the meet likely one of the first few weekends in March (12-13 March is leading candidate). Marcia encouraged everyone to support the Zone meet.

Mark briefly covered the requirements for hosting (50 m pool, possibly open water, possibly diving well, classroom space) and target of about 70 coaches and 125 swimmers participating. The program includes ASCA Coaching Certification as well as working with swimmers. Oct 15 is deadline for submitting application to host SwimFest dates are negotiable but are generally late spring-early summer (dates are venue specific).
- 7. Marcia encouraged the LMSC Chairs to disseminate Zone information to their local groups. Erin suggested Marcia send her updates to all the delegates present. Marcia agreed and will start sending updates out if delegates want any information sent out, they can send info to Marcia so she can send out.
