MINUTES:

1) CALL TO ORDER: The meeting was called to order at 5:36pm EST.

2) APPROVAL OF LAST MEETING'S MINUTES: (Bob)

Motion by Nancy Kryka to approve, 2nd by Scott Bay. After discussion, motion fails.

Meegan: I think it would be easier to include the summaries in the notes rather than as attachments. So, if Cheryl can revise & resend.

Cheryl: Some, like the Treasurer's report, can't be incorporated into the notes, so there will have to be some attachments.

Bob: Cheryl, if you can work the summaries into the notes, email the update and we'll approve online.

3) **COMMITTEE REPORTS**:

A. 2017-2018 Budget - Nancy Kryka

Big budget items for 2018:

- 1) 2018 Convention in Jacksonville, FL Do we know if USMS will provide us with funds for a social? Our Finance Subcommitte of Scott Bay, David Minor and Meegan Wilson and myself thought of either giving the attendees a free night out (meaning they can do whatever they want) or No Social at all. Or, maybe doing a dessert social lower cost than providing dinner.
- 2) Pan AMs: in 2013 we spent \$5,000 for the meet in Sarasota, FL expenses and \$4000 for the social, total \$9000.

Jillian: In 2013, Sarasota didn't use Club Assistant. For 2018, I'd like to see if we can subsidize the USA swimmers registration fees @ ~\$1.50/swimmer, maximum spend of \$5,000. For the Social, I'd ask the same amount, \$4,000 toward the social. We estimate the social to cost \$25,000 or \$30/person which includes 2 drinks, appetizers and pay for entertainment.

Nancy: with our Budget, we cannot do both USMS Social at Convention and Pan AMs. I'd like to make a motion that the FL LMSC donates \$9,000 to the Orlando YMCA for Pan AM expenses. 2nd by Cheryl. All in favor, none opposed – motion passes.

3) Other items

Coaching certification: will we need \$1,000 for 2018? Jillian: no, I'd say ½ or \$500.

Travel: since most of us will be driving to Convention, I would reduce that # from \$1,400 to \$400.

Motion by Scott to approve the 2018 budget with all the items above incorporated? 2^{nd} by Joan. All in Favor, non opposed – motion passes.

B. **Registrar Report** – Meredith Moore

Can we resolve the Club fees for 2018, are we raising them or not?

Bob: I'd like to table the club fees for the next meeting as I believe we've already approved not raising 2018 fees.

2017 Annual Report

As of October 12, 2017, we have 2419 swimmers registered in the FL LMSC for 2017

(November 1, 2016 - October 12, 2017)

That represents about a 9% decrease over 2016's final October figure of 2408.

USMS National Registrations are down about 10% in 2017.

- *1,763 were registered in 2016 (73%)
- *189 were registered anytime between 1988-2015 (8%)
- *467 were brand new members (19%)

In 2017, more swimmers renewed their membership from the previous year than in 2016 from 2015 (62%).

However, we had far less brand new registrations than in 2016 (30%)

53% are male, 47% are female.

99% of registrations were done online; 1% by paper.

So far, the FL LMSC had 495 Late Season registrations (Sept 1 - Oct 31). 381

(77%) opted for the "End of Year" plus 2018 membership and 114 (23%) opted for

just the End of Year membership.

We had a total of 69 Clubs registered in 2016; 62 Clubs in 2016.

Registrar report (continued)

We had 2 active Workout Groups of FACT: CLCF (Clearwater) and VASF (The Villages). Club registration for 2018 started on October 1st. So far, only 19 Clubs have registered for 2018. All Clubs MUST be registered by October 31st.

2018 swimmer registration begins on November 1st. Clubs must be registered in order for swimmers to register for a particular Club. We have around 50 Clubs that still need to register for 2018. Also, a Parent Club must register before any Workout Group can register with a parent Club.

I look forward to working to working with our Board, the FL LMSC, USMS and our Club Reps and swimmers in 2018. Thank you all again for for all your support and the opportunity to be your FL LMSC Registrar.

C. Senior Games Liaison Report – Joan Campbell

Sanction fees for non-recognized meets. I spoke to the Sr Games organizer and he said that the State will pay the sanction fees for the 7-8 meets. \leftarrow in notes on finance report, we would pay $\frac{1}{2}$ of the non-recognized meets or \$400.

- --The Florida State Games to be held at the Long Center in Clearwater December 2nd and 3rd will not be a qualifying meet for the 2019 National Senior Games. The State Senior games in 2018 will be and the games in 2019 will be held in Albuquerque, New Mexico.
- --I understand that the Gainesville Senior Games were Recognized and approved this year. Thanks to Gary Henderson for creating a smooth competition.
- --Meegan has done a bang-up job with instructions on applying for Sanction and Recognition and running a meet for all of you Meet Directors. Everything is on floridalmsc.org. Any questions from the Florida State Games can be seen on floridaseniorgames.com.
- --Because of widespread comments about the \$100.00 fee thrust upon us for Recognized events, I went to Convention this year and addressed the problem. Mainly for the State of Florida I am considering all the local senior games that wish to be Recognized by USMS. The LMSC is assisting with the fee this year but I am in contact with the State Games and will let you know shortly whether it is necessary for the LMSC to cover this fee for local games. I am also addressing the fee situation with the Finance Committee through one of its members. It was suggested that I write to her with the changes we would like to have and they will direct the question to the Board of Directors. —Joannie Campbell
