- USMS is currently awarding Covid grants to teams with matching funds from the LMSC. Carrie Stolar, MN At-Large Rep stated ND LMSC will receive a \$500 grant with no matching funds needed from the LMSC (since we are a small LMSC). The \$500 is to be used to help teams with yearly registration fee (\$60) and with sanction/recognition fees for meets. Awarded grants will be auto deposited into the LMSC account.
