- Visitor: Pete Tarnapoll was introduced as a visitor who swims with the New Albany Club. Pete has expressed a strong interest in being more involved with the Board. Pete is under serious consideration for an appointment as Vice-Chair to fill the balance of Franklins term and he has also expressed an interest assuming responsibility for the Secretary and Marketing positions. The appointment is pending Carl discussing Pete's qualifications with the rest of the Board in the next week or so.

Chair Carl Bromer called the meeting to order and declared a quorum present.

Minutes: The meeting was called to order at 8:00 pm EDT.

- a.) Minutes from our last official meeting February 6, 2014) were reviewed and approved.
- b.) Carl announced: Franklin Halley has resigned as Vice-Chair and accepted an At-Large appointment on the Board.
- c.) Carl announced that Barb Riazzi has resigned as Coaches chair and Jason Hill will assume Coaches Chair responsibilities for the balance of Barb's term *(Through the election in March 2015)* Barb agreed to help with the Coaches Clinic that is scheduled for October 25th of this year.
- d.) Carl announced the resignation of Tom Herringer as a Member at Large. The position will not be filled
- e.) The Board discussed the approval of funds to pay for an IT person to assume responsibility for our web page and to work with a new position that we are creating to do a better job of Marketing the Ohio LMSC. Motion was made and seconded to approve \$500 per year funding prorated and paid annually in December of each year. After discussion, the vote was unanimous. The job description will be reviewed and updated as part of the project to update our policies and procedures that Carl and CJ will be working on this summer.
- f.) We discussed the possible approval of Scholarships for Ohio LMSC member swimmers who attend the October 25th Coaches Clinic that will be held in the Dayton area. Motion was made and seconded to approve a \$15 scholarship for LMSC members who attend one Certification level (1 or 2) and \$30 for any LMSC member who attends both (Level 1 and 2). Vote was unanimous. Carl will notify USMS that this is the scholarship we are offering for this clinic.
- g.) Carl announced that he will be talking with each Board member in the next week or so to discuss Board appointments to fill current vacancies. He also suggested a re-definition of the Board (See Attachment E) that would reduce the size of the Board to 9 or 10 people by combining several positions. The final structure will be voted on by the Board before it becomes official.
- h.) Carl announced that we have two delegates who can attend the National Convention in Jacksonville in September. As Chair, he will fill one of those slots and one other person may be appointed to the other slot. The Board will have final approval on this also and it may be handled through a telephone survey.
- i.) Carl announced that the policy and bylaws are being rewritten and will be presented for approval at future Board and Annual meetings.
- g.) Floor was opened for new business and general discussion... There were no additional business or discussion.

The only thing I would need to discuss at the meeting is just informing other board members that they can refer somebody to me either at the meet (meet directors included) or via email if they have questions regarding the results posted, etc. Everything else is going well from a Top Ten perspective!

As I have been uploading and auditing the results of the Arnold meet I would like to add something to discuss at our meeting....

Either 1. we need to encourage clubs to use a "club assistant" sign up like Anderson is using that pulls names directly from the USMS database, OR 2. we need to change the paper sign-up form to state "Name AS IT APPEARS ON USMS CARD: ______" Too many people enter nicknames, some of which are actually not even CLOSE to their real "USMS" name, making it really hard for me to find these people in the system, especially if their USMS # is not entered correctly! I know this issue will never be completely taken care of, that's why I have a board position so I can make the corrections, but this might help me out a little bit!

3 Officials' Report: 2014 Officials Chair Annual Report...

FINA Changes to USMS Rules (Effective Sep 25, 2013 unless otherwise noted):

Breaststroke/Butterfly: The FINA Technical Swimming Committee has issued a clarification regarding the interpretation of the new rules about separated hands at the touch for breaststroke (USMS article 101.2.4) and butterfly (USMS articles 101.3.4 and 101.3.5). The updated interpretation will apply to USMS competition immediately and replaces the USMS interpretation issued September 25, 2013. USA Swimming has also published the new interpretation. The 2014 USMS Rule Book is available online at usms.org. Text of the clarification from FINA:

"Separated" means that the hands cannot be stacked one on top of the other. It is not necessary to see space between the hands. Incidental contact at the fingers is not a concern.

FINA further states, "It is important that officials use common sense. Please also see attached a file which clearly illustrates the sense of the rules."

<u>Unattached Swimmers</u>: All swimmers in a meet must belong to a club. If there is even one unattached swimmer competing at a short course or long course meters meet, NONE of the times from that meet will count for FINA Top 10 and World Records. This rule change is necessary to comply with recent FINA rule changes that will disallow any times from USMS long course and short course meters meets for FINA Top 10 and World Records if a swimmer who does not belong to a club competes in the meet. All other rules regarding unattached swimmers will continue to function as previously interpreted (102.9.1 p. 7, 104.5.4A[3] pp. 32-33, 201.1.2 p. 53, 201.1.3A p. 53, 201.1.3Bp. 53, and 201.3.5 pp. 54-55). All currently unattached swimmers will automatically be registered with the club Unattached and do not have to notify their registrars.

<u>Swimwear:</u> FINA and USA Swimming have added power bands and adhesive substances to the list of devices or substances that are not permitted:

102.12 Swimwear for Pool Competition

102.12.1 Design

E No swimmer is permitted to wear or use any device or substance to enhance speed, pace, buoyancy or endurance during a race (such as webbed gloves, fins, power bands, adhesive substances, snorkels, neoprene caps, etc.). Goggles...by the referee.

102.13 Disqualifications

102.13.9 No swimmers are permitted to wear or use any device or substance to enhance speed, pace, buoyancy or endurance during a race (such as webbed gloves, fins, power bands, adhesive substances, snorkels, neoprene caps, etc.). Goggles may be used.
