Summary of OMS Discussions via email prior to meeting

a. Tim noted that OMS still needs to reimburse the Portland Bridge Swim for the food that was provided during the OMS 50th Anniversary "Beach Party" event at Cathedral Park. Tim attached the invoice from Tamale Boy. We agree to pay our portion of the food vendor bill which is a total of \$2277.00. Tim moves to reimburse the Portland Bridge Swim \$2277.00 for the Beach Party expenses. Jacki seconds. Motion passes via email with no discussion

Minutes of Annual Retreat Meeting

The meeting was called to order at 10:00 AM.

- 1. 2022 Convention (Tim)
 - a. The fee increases were approved, even though when the unified fee was introduced, we were told fees would not increase for five years.
 - b. The National Office is focusing on promoting things at the local level- open water events, clinics, meets, etc.
- 2. Souvenirs (Jeanna)
 - a. The 50th anniversary caps have been distributed.
 - b. People are requesting the gear exchanges at the meets again. Jeanna will trial a gear exchange at the next swim meet.
 - c. Swim Outlet team store is moving forward, but the logo needs to be reformatted. Jeanna is going to reach out to Bonnie, the former webmaster, for assistance with the logo.
- 3. Safety (Joy)
 - a. We have new laminated No Diving signs, an ample supply of safety vests.
 - b. Incident report forms are updated. We are in good shape for safety.
 - c. Jeanna is a lifeguard now, and thought the test was simple and easy.
- 4. Aquamaster (Alice)
 - a. Alice is transitioning the AquaMaster role to Bonnie. Bonnie is able to use the InDesign format, so the transition should be seamless.
 - Alice has also been creating the awards booklet using the photos that are printed in the AquaMaster. Alice has not checked with Bonnie about her willingness to create the awards booklet. If Bonnie is not willing, Alice could continue as long as she has access to the pictures.
 - c. Through Mailchimp, Alice can tell how many people are clicking on each article, but it does not appear that there are many readers. 25 clicks would be a good article. Kermit thinks it would be helpful to know the readership data so we can use it to examine the future of the AquaMaster. Bonnie is going to send the data to Kermit for analysis.

5. Fitness (Colette)

- a. Clinics
 - Colette is looking at running two clinics next year in Vancouver. The preference would be for 4-5 technique clinics each year, with a focus on more low-level swimmers. Preference would be to allow both USMS and non-USMS swimmers.
 - USMS insurance is high, so the clinics may be higher cost for the attendees. Would we like to have a standard set fee for clinics, as we do for meets? Private swimming lessons are \$25 for a ¹/₂-hour. That makes a \$50 clinic cost-effective. Tim would like to see more clinics, preferably stroke-specific.
 - iii. Sandi does not have many signed up for the stroke clinic next weekend, nor for the coach's clinic. Sandi asks the OMS board to promote the events.
 - iv. For the 2023 budget, Tim and Collette will put together some tentative budgets for clinics and provide them to Kermit. We should consider clinics in other parts of the state, as well. Outside of the Portland area, there are workout groups in Ashland, Bend, Corvallis, Eugene, Hood River, Medford, Salem, St. Helens, and Toledo.
- 6. Membership (Christina)
 - a. Christina shared the registration fees for 2021 and 2022. It gets more complicated for 2023 because the numbers change depending on when the workout groups register.
 - b. There were 1114 members last year, 19 workout groups, and 5 clubs. Some of the clubs may have registered as clubs instead of as workout groups.
- 7. Vice Chair (Robbert)
 - a. 2022-2023 Pool Schedule
 - i. Tim has been in touch with The Dalles to host a meet in July. This will be a combined effort with different members of the OMS board to help them by hosting the meet.
 - ii. Willamalane in Springfield is also interested in hosting a meet. This is a very nice facility similar to North Clackamas Aquatic Park.
 - iii. MAC is planning to host a meet.
 - iv. Gold's Gym bought the Lacamas pool. This may be an option for us in the future.
 - b. Pool rental fees
 - i. The pool rental fees are increasing. Perhaps OMS can consider paying the pool rental fees for meets. Pools can use the resources of their high school swim teams for officials and timers, etc. Eliminating the need to pay pool rental fees would allow the meet hosts to make money from hosting the meet.
- 8. Long Distance/Open Water (Bob, via Zoom)
 - a. Tentative 2023 Open Water Schedule

June 11- Lake Juniper- Sunday morning event.

July 9- Portland Bridge Swim is the weekend before Foster Lake. This will start the "Your Oregon Swimcation" July 13- Foster Lake Cable Swim.

July 15-16- Southern Oregon Open Water Swims at Applegate Lake

July 29- Cascade Lakes Swim Festival at Elk Lake. Bob is hoping this can be a two- or three- day event.

August 12- Oregon Coast Wild Swims at Eel Lake. This date is flexible depending on the pool meet schedule

- b. Pool schedule information
 - i. The problem with the proposed date in April for the Associations meet in Bend is that Bob will be out of the country that weekend. The next best weekend will be May 12-13.
 - ii. Tim asked if Bob would have interest to do a full-blown introduction to open water clinic during the Lake Juniper meet. Bob would prefer to have a separate date for a clinic, keeping in mind the triathlon schedules.
 - iii. Bob suggested a return to the Gil Young long-course meet in the Portland area.
 - iv. Tim told Bob that we are looking at a pool meet in July at The Dalles. July 22nd weekend is the only available slot.
- c. Status of Foster Lake Cable Project
 - i. Bob filed a proposal with the Army Corps of Engineers to lay the cable, and finally got a response. They are "working on it" and will let him know when they have more information. If the Army Corps says yes, and if the base of the lake makes it feasible, then we will have a work party in January or February to lay the course.
- d. Additional comments on other topics:
 - i. One-event registration fees for 2022 are up to \$20 instead of \$15
 - ii. Officials- Bob agrees with Jacki's ideas on spending money for officials because we should prioritize funding more pool meets. Bob disagrees with the amount of on-deck training hours needed to become certified officials because it is not practical with not enough meets to do training.
 - iii. Reserve Funds- Bob disagrees with OMS paying money for workout group registration fees. Tim told Bob we were considering paying for pool fees for meets instead. Bob agrees this would be helpful.
- 9. Secretary (Kristina)
 - a. By-laws
 - i. Board members should be contributing members, but the bylaws are vague about what that means and what are the consequences for not participating. Christina recommended looking at other LMSC bylaws and policies.
 - ii. Sandi offered to help Kristina looking at the formatting during the winter season.
- 10. Officials (Jacki via email)

- a. Jacki asked the board to discuss the following:
 - i. Please add to host responsibilities for pool meets sending a list of officials that worked the meet to the LMSC Officials Chair. This can be delegated to the meet referee.
 - ii. Consider that OMS will reimburse lodging expenses for officials as follows:
 - One-day meet- 1 night for 1 official
 - Two-day meet- 1 night for up to 2 officials
 - Association meet- 2 nights for up to 3 officials
- b. Meet Hosts would still be responsible for the meet referee
- c. Kermit adds that Jacki's proposal for officials does not include a dollar amount. Before this proposal can be added to the budget, we need a dollar amount.
- 11. Webmaster (Tim/Robbert)
 - a. OMS Website is currently using WordPress, running on Matt's platform. Moving forward, a different platform may make more sense for us.
 - b. We do not necessarily need a Webmaster who knows how to code. There are plenty of easy platforms to use. There is a suggestion to advertise on AquaMaster that OMS is looking for a new webmaster.
 - c. The Webmaster could double as the communications person if it's a good fit for them.
- 12. Good of the Order
 - a. Possible board positions: Communications, Diversity & Inclusion could be additions. Christina adds there are resources out there for communications chairs at OMS.
 - b. What is the best approach to make sure the teams are going to make money for hosting meets? There are several approaches we could take. What is the balance point where we have enough meets to encourage activity from our members, but we're not going to lose money by providing pool rental fees for poorly attended meets.

OREG Club report by Nancy Vincent

OREG Board held its annual meeting on October 4, 2022. Toni Hecksel has resigned as Chair and Susan Albright has resigned as Secretary. The new OREG board is as follows:

Scott Sullivan - Chair Nancy Vincent - Vice Chair Pat Allender - Treasurer

Tom Phipps - Secretary

The main topic of discussion was the budget for 2023. The board expects to end 2022 with a balance of ~\$6100. We are projecting enough swimmers will attend Spring Nationals in Irvine to be able to send one or two coaches. We are not projecting enough swimmers will attend Summer Nationals in Florida to send a coach. For Nationals, we also have the associated expenses for relays, shirts, caps, and tents. With recent increases in travel expenses, we plan to increase reimbursement for Nationals coaches to \$250/day (from \$200/day) for the head coach and \$125/day (from \$100/day) for the assistant coach.

OREG Board is again requesting \$2800 in swimmer dues from OMS in 2023.

OREG had 16 swimmers register for Spring 2022 Nationals in San Antonio, which allowed us to send Bob Bruce as the team coach, for which \$800 of expenses were reimbursed. Other club expenses this year were club registration fees and relays fees for Spring Nationals and the Postal Events.
