PVLMSC "Annual" Meeting Minutes - October 24, 2010

- 1) Approval of minutes from last meeting.
- 2) Chair (Jeff Strahota)
 - PV funded 3 people to attend the USMS Convention
 - Four additional representatives (from PV) attended in other capacities (funded by USMS).
 - Three PV coaches attended SwimFest in San Diego and learned a lot.
 - Frank Marcinkowski is the new PV Coaches' Chair.
- 3) Registrar (Jeff Roddin)
 - PV is growing: registration (Oct 2008 = 2215, Oct 2009 = 2580, Oct 2010 = 2787)
 - We're experiencing 8% growth, almost twice the national average.
 - There is a new team: Potomac Open Water Swim (POWS).
 - All PV clubs renewed their PV membership for 2011.
- Currently our total individual swimmer registration fee is \$37. Previously \$25 went to USMS and \$12 went to PV. Now \$27 goes to USMS and \$10 to PV. Next year (2011), \$29 will go to USMS and \$8 to PV.
- Tim Timmons proposed that we keep the total dues at \$37 through 2011. In 2012, we could increase the dues to \$40 (\$30 for OEVT). The motion was approved.
- Jeff R. will send a broadcast email to each member giving a link to renew their membership. Clubs should notify Jeff by Nov. 1 if they want a customized email sent to their team members.
- 4) Top Ten (Jeff Roddin)
 - DCRP did an outstanding job on the Hains Point meet.
- Times from the MD Senior Olympics Meet were eligible for USMS Top Ten (only if the swimmer was USMS registered).
- 5) Sanctions (Debbie Morrin-Nordlund)
 - DCRP received a full refund for their meet
 - MD Senior Games did a good job
 - There is a new local Open Water event "New World OW Swim".
 - Permission to offer OEVT membership must be approved for each event.
 - Tropical Splash has an evaluator.
 - Frank Marcinkowski will evaluate the Albatross Open.
- 6) Treasurer (Tim Timmons)
- Doing great: \$51,445.14 in combined accounts. (\$20,800.40 in checking, \$30,644.74 in savings)
 - USMS sends PV its portion of the dues when a member registers online.
 - We spend the largest amounts on conventions and newsletters.
- We will assist any team financially who wishes to host a meet. We promise you'll at least break even or PV will subsidize the difference.

- 7) Newsletter (Cheryl Wagner)
 - Newsletter is now going out in January, May and September.
 - Will ask Jeff R to send an email reminder when the newsletter is ready

8) Awards (Julie Roddin)

- No report.

9) Officials (Eric Nordlund)

- Ask for a list of swim officials, if you need it.
- There is a program at the national level to train officials.

10) Fitness (Diana Corbin)

- 3000/6000 postal easy to organize.
- Hour Swim in January most popular in USMS.
- Swim in the New Year chance to do a postal.
- Go the Distance online tracking of yardage.
- Postals are a great way to make money.

11) Open Water/Long Distance (Denis Crean)

- A new local open water race was added last month.

12) Coaches (Frank Marcinkowski)

- Frank, Juliette deSouza, Dominic Latella and Lisa Wolf attended Swimfest in San Diego in July. Frank was an instructor.
- Could we host the next SwimFest? It takes two pools: 50 m & 25 yd, and a covered classroom.
- It's a money making event. 1/2 pool oriented, 1/2 open water oriented. Stroke technique for coaches. Underwater videotaping. Focus was "beginner to intermediate" although 50% of swimmers were "high-end".
 - Frank will send an agenda and report from Swimfest.
- Starting 2 days before the convention, first Masters ASCA certification Level I & II coaches' training. Limited to 35 or 40. For Level I, they put it online. Only \$50 for ASCA certification.

13) Old Business

- Two bylaws to amend
- . Team registration fee policy (\$100 to register a club, but if you come to at least one meeting during the year you receive a \$50 refund)
 - . Add Open Water/Long Distance committee to PV Board.
 - Online meet entry subsidy offered to teams who host meets.
- . The online meet entry program checks swimmers against the national database and helps Top Ten by producing "clean" records.
- . Tim Timmons proposed that PV pay 100% of online registration program costs during 2011, for any team that hosts a meet and uses the program. Motion was approved.
 - LMSC awards banquet will be organized by the next meeting.

- Jeff Roddin wishes to donate his \$100 Top Ten stipend to the USMS Foundation. Motion approved.
