Reports

Chair - Jeff Strahota

Thank you to all of your support over my last term, and to all our volunteers, I want to thank you for your service and assistance over these last 4 years.

This fall, I was elected as an at-large delegate to the USMS Board of Directors, and I look forward to being able to help guide our organization for the next couple of years.

Treasurer's Report – Tim Timmons

Financially, PVLMSC remains in good health. We currently have a combined total of \$57,359.20 in our Checking and Savings accounts. We began the year with a combined total of \$52,404.89 which means we are \$4,954.31 in the black for the calendar year to date.

During that timeframe, our income has totaled \$14,910.83 and our expenses have been \$9,956.52. Thus again, our net is \$4,954.31. Here are the details:

Income

- Registrations (Individual and Club) = \$14904.00
- Interest on bank accounts = \$6.83

Expenses

- Club Assistant Rebates to Clubs hosting meets = \$3,416.00
- ALTS Scholarships = \$500.00
- Miscellaneous = \$346.24
- Coaches Clinic Scholarships = \$360.00
- Convention Expenses = \$3,334.28
- Sanction Fees = \$2,000.00

I have no specific recommendations for the Board; we're in good shape.

Secretary – Jeff Strahota

We yet again saw a couple of email issues while getting the word out about our fall meeting (which Ray was able to handle), but otherwise, nothing to report.

Registrar – Jeff Roddin

Please continue to review your club listings on the PV website (http://pvmasters.org/newsite/index.php/clubs/) and let Ray or I know if anything needs updating.

Individual Membership totals for this time of year: October 31, 2014 – 2960 October 31, 2015 - 2847 October 31, 2016 – 2830 October 31, 2017 – 2704 October 19, 2018 - 2412 (downward trend continues - and is getting worse)

We have 34 registered clubs (vs 33 last year).

For 2018, we charged \$30 for OEVTs (and they could later upgrade to full membership by paying \$20). Of the \$30 fee, \$15 went to USMS and \$15 went to PV. For 2019, the USMS portion of the OEVT will increase by \$5 to \$20. We can keep the total fee at \$30 by reducing the PV portion to \$10, or we can pass along the increase to the swimmers.

For 2019, USMS has raised their portion of individual membership fees by \$2 (from \$43 to \$45). We have agreed to absorb this increase in order to keep the total registration fee at \$50 (i.e. the LMSC fee will decrease from \$7 to \$5). Our overall fee increased from \$40 to \$45 in 2014 and from \$45 to \$50 last year.

For 2019, USMS has raised their portion of club membership dues from \$43 to \$45. We have reduced the PV portion by \$2 per club to maintain the same overall fee to clubs (i.e. PV clubs won't notice the dues increase).

As of 10/22/18, 12 clubs have renewed for 2019: ANCM, ARMS, DCAC, GERM, GMUP, MASH, NXWV, PMM, RIPM, RMST, SDS, TRI3, WAV1

As of 10/22/18, 22 clubs have not yet renewed for 2019: ALEX, DCM, DCRP, DCTC, DUFF, ERSC, FBST, JCCN, L4S, LMAC, MACH, MSSC, NAMI, NCYM, SFAF, TA, TOLL, UMAC, WAVA, YBCC, YSS

Had only one LC Meet this summer: 194 swims, 1 national record submitted and accepted from Terrapin Cup.

Vice Chair/Rules – Dave Robinson

When the Rules Committee discussed our SCY relay proposal several months ago, they did not support it with a vote of 6-8, which is the closest this has ever been. I raised it again at a Rules Committee meeting at Convention, and it was also discussed and voted on the floor at Convention. It did not seem to even receive 50 % of the vote there.

Since only PV can propose rule changes, we should discuss next steps. We can #1 drop the issue, #2 re-propose it "as is", #3 create a "full blitz" larger proposal, or #4 some other approach. "Full blitz" options could include: conduct a poll at the Spring SCY Zones (Jeff's idea), have Karl Wunderlich, Ph.D. (professional statistician and originator of the Crescendo Relay handicapping) do a thorough analysis on 20 years of USMS data, and/or submit a detailed rebuttal of points raised against our proposal.

Based on a legislation proposal that was submitted this year, there was a potential wording change that could be discussed at a later meeting.

2018 Rule Changes that may affect us (Strahota, Grover)

- One Event Fee (USMS portion is \$20) see motion from Jeff Roddin's Registrar Report.
- Records Somewhat reverted the National Record requirements (for national records only) that would permit 2 watches in the event of total system failure.
- Cameras behind the blocks on Jan 1 2019, no cameras will be allowed behind the blocks at the start of the race.

Jim McDonnell Lake Swim (Lee, Evans)

- Peter passed out some paperwork showing the timeline of events, number of safety personnel, and official team statement. Safety plan worked as designed.
- How we as an LMSC can help more in the future? Having Peter there was extremely helpful. Was helpful to hear from Dawson. Could be helpful to have an EAP-designated person (PV OW Official) to help handle the family and friends.
- MSA to Establish a subcommittee to look into some of the suggestions of how to handle emergencies. (Stephanie, Cheryl) Peter, Tom and Frank would like to be on the subcommittee.
- For 2019 Reston Association (RA), who owns the lake, is continuing to raise the requirements for approval. For 2019, are requiring OW-certified lifeguards. Team support exists to continue the event, but are continuing to wait for what additional requirements will come from RA.

Backstroke Ledges (Robinson)
