Minutes

The meeting was called to order at 2:30 PM.

It was noted that all proposal numbers refer to the Proposed Changes to USMS Rules distributed in the Convention packet.

- 1. The USA Swimming Amendments were presented and briefly reviewed.
- <u>R1a</u> Tingley, Dillon moved, second to take R1a off the Table. MSA Letendre, Dillon moved, second to reconsider R1a and to recommend it to the HOD as Housekeeping because it is part of the USA Rules changes from last year. MSA to recommend for approval by the HOD as Housekeeping. (unanimous)
- R1c Tingley, Dillon moved, second, to remove R1c from the Table. MSA MS to consider R1c as an emergency. Failed, R1c is not deemed an emergency. (1 yes, 14 no, 1 abstention)
 R2 Crittenden, Dillon moved, second to approve R2 as an emergency proposal.
- <u>K2</u> Crittenden, Dillon moved, second to approve R2 as an emergency proposal.
 Failed. R2 is not deemed an emergency. (unanimous)
 Letendre, Tingley moved to consider R2 as Housekeeping because it is part of the USA Rules changes from last year.
 MSA to consider R2 as Housekeeping and recommend for approval by the HOD. (unanimous)
- <u>R3</u> Crittenden, Dillon moved, second to approve R3. Discussion about whether this rule would conflict with FINA rules and it was decided there has not been a conflict. MSF, R3 is not recommended. (1 yes, 15 no) Letendre, Tingley move to withdraw R3 approved. (unanimous) R3 is withdrawn.

- <u>R4</u> Crittenden, Dillon Moved, second to approve R4. Tingley, Letendre moved to amend R4 to remove the strikeouts from 102.17. MSA to amend R4. (unanimous)
 Fasbender, Hooper moved, second to change wording to read: "Smoking and use of other tobacco products is prohibited." Motion failed (2 yes, 14 no)
 Trimble, Dillon Motion to withdraw R4. Motion passed. R4 is withdrawn.
- Letendre, Dillon moved, second to recommend that the HOD approve the request by the Championship Committee to suspend rule 103.12.2C and the two-timer requirement in104.5.10C for the 2012 Summer Nationals in Omaha. MSA (15 yes, 1 no)
- 8. <u>**R6, R7, R8, R9, R10, R11**</u> Tingley, Boak moved, second that R6, R7, R8, R9, R10, R11 be considered together and be recommended because they are all consistent with language adopted by USA Swimming in 2010. MSA (unanimous)
- 9. <u>**R5**</u>. Crittenden, Dillon moved, second to approve R5. MSA (unanimous) The word "referee" should be underlined.
- Boak, Dillon moved to accept RO1, RO2, RO3, RO4, and RO5 together because they have the same rationale that they are changes that are consistent with the USA Swimming 2010 reorganization of the corresponding articles. MSA (unanimous)
