## f. Issues from the floor

i. Bob Colyer from LOCO advised Mike at the mee this weekend that we should look at not allowing NT entries in meets so that "fast" folks do not end up in the first heat with some of our members who need longer to swim events. Mike checked with Erin Sizelove on PALM if we can turn off NT's in ClubAssistant. The group discussed the potential for having Meet Directors take on policing entry times and if that would be beneficial or potentially inhibit Directors from hosting meets. We agreed to partner with our Coaches' Chair to work with all LMSC coaches to advise their swimmers ahead of meets that it is OK to guess a time/enter a time similar to practice times (we are not like USA Swimming so this is OK.)
