Greetings from the National Office...

I hope all is well with you and your LMSC!

Now that this newsletter is being sent out via email, I am now increasing the circulation to include all who attended convention (not just members of the BOD) and all LMSC Officers (not just the Chairmen, Registrars and Editors). The goal is to increase communication and relay important information out to our members.

Address Changes - For the registration year 2000, the National Office has inputted over **3,000** address changes, the majority of which (approximately 95%) are received from SWIM Magazine (meaning, these were not reported to us).

Every other month, USMS sends "the most up-to-date" membership database to a company who creates the labels for SWIM. SWIM is sent out "second class mail" and this means... **if you or one of your members have moved and have not told us, your magazine WILL NOT BE FORWARDED.**

In order to keep track of this, a fee is paid and the magazines and/or labels are sent back to Sports Publications from the post office, with a notation of why it was not delivered. These in turn are sent to the National Office where we up-date our records and send the names/changes to the appropriate LMSC Registrars.

As you can imagine, this is a rather tedious process and there a lot of people who are not receiving there SWIM Magazine. Please spread the word **IF YOU ARE MOVING, PLEASE CONTACT YOUR LOCAL REGISTRAR AND/OR THE NATIONAL OFFICE ASAP!**

Would you believe that we have already received address changes for 2001! Here we go again!!!

WHO WILL IT BE IN 2001

RANSOM ARTHUR AWARD NOMINATIONS

The Ransom Arthur Award is USMS's most prestigious award. It is presented annually to the person who is deemed by the committee to have done the most to further the objectives of Masters swimming programs.

GOALS AND OBJECTIVES

- A. To encourage and promote improved physical fitness and health in adults.
- B. To offer adults the opportunity to participate in a lifelong fitness and/or competitive swimming program.
- C. To encourage organizations and communities to establish and sponsor Masters swimming programs.
- D. To enhance fellowship and camaraderie among Masters swimmers.
- E. To stimulate research in the sociology and physiology of Masters swimming.

Any member of USMS may nominate a worthy person for this award. Each nomination:

- 1. MUST be endorsed by an LMSC.
- 2. MUST be limited to a one-page-only (8 1/2 x 11") application form.
- 3. May include an optional, one-page-only letter of endorsement.

The one-page applications form may be produced on computer or submitted on the attached application form. Computer-generated application forms must be one page only and must follow the exact format and order of information as shown on the attached application form. Application forms longer than one page or using a different format will be returned. ONE one-page letter of endorsement may be submitted. Any additional material will not be considered.

Nomination deadline is April 15, 2001. All completed nomination forms must be in the hands of the Mary Lee Watson, Recognition and Awards Chair on or before that date. They will then be circulated to Recognition and Awards Committee members who will give careful consideration to all nominations and make the final selection. The award recipient will be announced at the 2001 Short Course Nationals in Santa Clara, California in May.

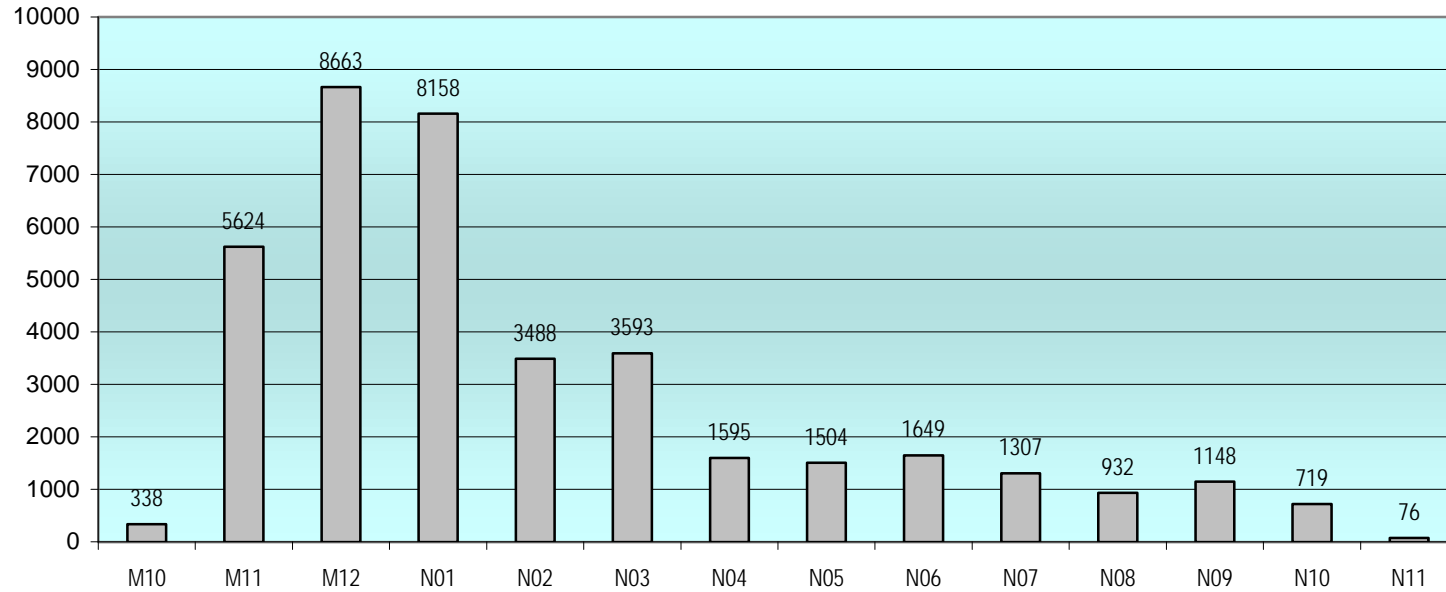

 (in determining status of swimmer, the affiliation at the end of last year is considered first, even though s/he may have belonged to the same LMSC previously)
