**Facility:** The Hardin Community Center is an indoor, 8-lane 25-yd competition pool. An additional warm-up pool is available during competition. Located at Hardin Community Center, 621 8th St. W., Hardin, Montana, 59034, United States. Phone: (406) 665-2346. The complex has plenty of seating area indoors, plus a large enclosed outdoor patio. Bleachers are available, or bring your own chair.

**Directions & Parking:** Take the Hardin exit 495 off of I-90. Turn toward City Center, and continue on North Crawford Avenue to 11<sup>th</sup> Street West. Veer right onto N Mitchell Avenue, continuing to 8<sup>th</sup> Street West. The complex will be on your left. Plenty of parking is available in the parking lot and along the adjacent streets.

**Rules/ Eligibility:** The 2012 USMS Swimming and Montana Masters Swimming Rules will govern the conduct of the meet. Timing will be by Colorado Timing System or watches as backup. All events will be timed finals. Swimmers must be at least 18 years old on the day of the meet. All swimmers must have a current USMS Swimming card, or be covered by the USMS one-event/meet registration form for insurance purposes. Forms will be available prior to the start of the meet. Swimmers are limited to five individual events, and one relay. The Meet Referee will have final authority for the conduct of the meet. Meet Referees may change order of events, add or combine to accommodate swimmers. Disabled swimmers are welcome. The Meet Director must be notified prior to the entry deadline of any accommodation required for a disabled swimmer. The Meet Referee will have final say on whether deck entries for disabled swimmers requiring accommodation will be allowed.

**Entries:** E-mail entries are preferred. E-mail entry deadline is 6:00 PM MDT on Thursday, June 7, 2012. The paper pre-entry postmark deadline is Friday, June 1, 2012. On deck registration is permitted. Deck entries for the 500 yd. Freestyle will close at 9:30 AM, All other deck entries may be made until the 1<sup>st</sup> heat of the prior event.

**Entry Fees:** \$25.00 per swimmer flat fee. Deck entries and e-mail entries after the June 7<sup>th</sup> deadline are allowed for \$35.00 flat fee. For swimmers in relays only, the fee is \$5.00. Checks payable to MOB (Master's of Billings). No refunds will be given. Swimmers must be USMS registered, or if not must sign a "one-event" form for the meet, cost is \$18.00.

**Seeding:** All events will be deck-seeded slowest to fastest by entered time, ages and genders combined. No time entries will swim in the first heat. Reasonable estimates for seed time will be accepted in lieu of no-time entries.

**Relays:** For each relay swimmer who is not entered in individual events, a fee of 5.00 and a signed liability release must be submitted with the relay entry. No Charge for the 4 x 50 "T-shirt" relay. Each team member must swim with a T-shirt on. The shirt is exchanged from one swimmer to the next. Bring a T-shirt to use. This is quite a comical event and loads of fun.

Awards: Each swimmer will receive a participation award. No individual awards will be presented

Snack Bar: Food and swimming equipment vendors will be available for purchase at the pool.
