In consideration of being allowed to participate as an athlete and/or as a volunteer with the event, I, the undersigned do understand, acknowledge and agree to the following:

1. Participation as an athlete subjects me to activities that are potentially hazardous to my health and the risk of serious injury/death resulting from my participation is significant.

2. I certify that I am medically able to participate in these activities and I hereby knowingly assume all risks to my health, both known and unknown, from my participation as an athlete and/or volunteer including but not limited to falls, accidental submersion by other participants, contact with other participants, the effect of the weather (including extreme heat, humidity, lighting) the condition of the sports venue and equipment, boat (lake/water) traffic, with all of these risks being assumed by me, known by me and appreciated by me.

3. I also understand that photos and/or videos are occasionally taken during the event and that any photo and/or video taken of me may be used for publicity purposes. I hereby agree to the use by the event, its subsidiaries or assigns, of a photo and/or video of me without payment, for the event, its subsidiaries or assigns, use in its promotional materials and, in connection therewith I, on behalf of myself, my children, my family, my heirs, executors and assigns do hereby release the event, and their respective directors, officers, employees, agents, subsidiaries and assigns from any and all claims or charges arising in connection with the use of any photo and/or video of me, in whole or in part, in whatever manner the event determines as part of the production of such video or promotional materials produced in connection therewith.

I certify the I have read and fully understand all of the terms of this waiver of liability, and that I, for myself and for anyone entitled to act on my behalf, do voluntarily waive and release One Step Beyond, One Step Beyond Cary Masters, FS Series, Jordan Lake State Recreation Area, and all sponsors and beneficiaries of the swim event (including their representatives and successors), from any and all claims or liabilities of any kind arising from my participation as an athlete or volunteer in the 2012 swim.

6. I understand there is a time limit: Swimmers who cannot complete 1.2 miles in 60 minutes or 2.4 miles in 120 minutes should NOT enter; swimmers on the course after these time limits may be stopped and listed as DNF in the results.

USMS LIABILITY RELEASE: I, the undersigned participant, intending to be legally bound, hereby certify that I am physically fit and have not been otherwise informed by a physician. I acknowledge that I am aware of all the risks inherent in Masters swimming (training and competition), including possible permanent disability or death, and agree to assume all of those risks. AS A CONDITION OF MY PARTICIPATION IN THE MASTERS SWIMMING PROGRAM OR ANY ACTIVITIES INCIDENT THERETO, I HEREBY WAIVE ANY AND ALL RIGHTS TO CLAIMS FOR LOSS OR DAMAGES, INCLUDING ALL CLAIMS FOR LOSS OR DAMAGES CAUSED BY THE NEGLIGENCE, ACTIVE OR PASSIVE, OF THE FOLLOWING: UNITED STATES MASTERS SWIMMING, INC., THE LOCAL MASTERS SWIMMING COMMITTEES, THE CLUBS, HOST FACITLITIES, MEET SPONSORS, MEET COMMITTEES, OR ANY INDIVIDUALS OFFICIATING AT THE MEETS OR SUPERVISING SUCH ACTIVITIES. In addition, I agree to abide by and be governed by the rules of USMS. Finally, I specifically acknowledge that I am aware of all the risks inherent in open water swimming, and agree to assume those risks.
