RULES	2014 USMS rules will govern this meet. Meet management reserves the right to adjust logistics in order to run an efficient meet.	
BREAKS	There will be a 10-minute break after the 50 Free, 50 Breast, and 100 Fly.	
ENTRIES	Competitors may enter up to a maximum of five (5) individual events. The 400 meter free may be swum combined men and women, and will be deck seeded with a positive check in. Check in deadline for the 400 free is 9:30 am.	
DECK ENTRIES	Deck entries will be accepted on the day of the meet up to 9:30 am for an added charge. Entries are only permitted in open lanes, no new heats will be added. "Double Entry Fee" if not already entered in meet. "\$5.00 per event" if already entered in meet. Must bring a copy of your 2014 USMS Registration Card.
