# Masters in Meters at Mason

**Sunday October 26<sup>th</sup>, 2014**

**Facility/Location:** Mason High School Natatorium is located at 1001 S. Barnes St. Mason, MI 48854. The pool has 8 lanes in meters with Colorado Timing System and will have continuous warm up/cool down available. The majority of each lane is 7 feet or deeper water. There is plenty of parking and seating for spectators. We have four locker rooms so there is plenty of space available; Mason is not responsible for lost or stolen items, so please bring a lock. The deck is bright and spacious with several risers for athlete seating. This meet will be swim as short course meters (SCM). The length of the competition course without a bulkhead is in compliance and on file with USMS in accordance with articles 105.1.7 and 107.2.1.

**Meet Conduct:** 2014 USMS Rules will govern conduct of this short-course meters meet.

**Eligibility:** All swimmers must be registered with USMS (proof required). A Photocopy of your 2014 Membership should accompany your entry. If you're not currently a member, you can join online at <http://registration.usms.org/>  
**Swimmer's age is determined as of 12/31/14 for this Short Course Meters meet.**

**Records:** Swimmers attempting to set records during the meet should notify the Referee to assure that three official timers will be present.

**Seeding & Heats:** All events will be timed finals. Swimmers will be seeded on basis of submitted times regardless of age. Men and Women will be seeded together. Entrants submitting "no time" may be placed in the slowest heat for that event. Heats will be swum from slow to fast. Heat sheets will be posted around the deck.

**Entries:** The entry form is on the following page. Paper entry deadline is: October 21, 2014. Entries post marked by October 17 or received by fax by October 21 are \$25. Deck entries are \$35. Checks should be made payable to **Mason Swim & Dive. A photocopy of membership and fees** can be mailed with entry to: Connie Cantrell, **Mason High School, 1001 S. Barnes St., Mason, MI 48854** or faxed Attn: Connie Cantrell at 517-244-1600. Entry fees will be due at check-in for faxed entries. Each competitor may enter a maximum of **5 events**.

**Relays:** Relay cards may be obtained at the check in table. Relays are always fun and we encourage you to put a group together. Relay entries/cards are due at the beginning of session 2.

**Directions:** From US 96 take US 127 Southbound -- Exit Kipp Rd. Turn left. Drive through two lights, over rail road tracks, and take next left on to Barnes Street. The High School will be on your right. Turn in to the 2<sup>nd</sup> or 3<sup>rd</sup> drive and go behind the building on the North side. There is some parking by the Aquatics entrance with additional space in the front and south lots.
