

**High Ridge Dolphins Masters Meet**

- Time:** Warm-ups 7-8am. Competition begins at 8am.  
All swimmers must check in by 7:30am.
- Location:** High Ridge YMCA, 2424 W. Touhy Ave., Chicago, IL, 60645.  
The Y is located at the intersection of Touhy and Western Ave.  
Enter the parking lot off of Western, just north of the intersection.
- Facility:** 5-lane, 25 yard pool with Kiefer Advantage I lane lines and S.R. Smith Legacy starting platforms. The meet will be run using 4 lanes, with lane 5 open for warm-up/cool-down throughout the duration of the meet. 3 watch times will be used for timing in all lanes.  
*The length of the competition course without a bulkhead is in compliance and on file with USMS in accordance with articles 105.1.7 and 107.2.1.*
- Meet Conduct:** 2015 USMS Rules will govern the conduct of this meet. All events will be timed finals. All events will be mixed, and swum slowest to fastest.
- Officials:** John Imperial, Ken Ayers, David Leistensnider
- Eligibility:** Must be over 18 years of age and a 2015 USMS member. In accordance with USMS rules, a photocopy of your USMS card must be provided with your entry and waiver. - Entries:** \$25 flat entry fee for advanced entries. Swimmers may enter up to 5 individual events, plus relays. There will be a \$5 surcharge for deck entries. Deck entries will be accepted until 7:30am the day of the meet.
