Schedule: 1 Mile: Check-in closes 9:00 AM Pre-race instructions 9:15 AM Race starts 9:30 AM
800m "cable" Check-in closes 10:30 AM Pre-race instructions 10:45 AM First heat 11:00 AM
 Participants swim in heats according to time and preferred direction (see entry, below) around a 400m long cable, for a total of 800m.

Course: The course will be marked by buoys and line markers for the cable swim. Water temperature is expected to be 74-76 degrees and will be posted at check-in.

Equipment: The use of pull buoys or fins is not allowed. Swimmers wearing wetsuits are ineligible for awards. Other USMS open water swimming rules applicable.

Safety: The course will have safety marshals, lifeguards, a boat patrol (including a lead boat, a chase boat, perimeter boats, and an "ambulance" boat. In addition paramedics and an ambulance will be at the site during the swim. (No pets at the race, please)

Eligibility: Open to all USMS (U.S. Masters Swimming) members. Every swimmer must be a current USMS member to compete.

Awards: Awards given to all finishers up to 8th place and national championship patches to each age group winner.

Picnic: Following the swim, Emerald Aquatics will host a potluck. All are invited (\$5 for non-swimmers).

Directions: From I-5 take exit 174 and go east to the reservoir. Follow Row River Road on the north side of the lake for two miles to Harms Park. Signs will be provided on Row River road. (see map, opposite)
