Open water Clinic – Saturday, May 26, 2007 Benefits the Lymphoma Foundation of America

Sanctioned by Potomac Valley LMSC for USMS, Inc - Sanction #107-04

Events:

- McDonnell 1-mile swim: approximately 7:30 am.
- McDonnell 2-mile swim: approximately 8:30 am.
- USMS 1-mile championship swim: approximately 10:30am.

Open Water Clinic:

- There will be open water clinics on May 26 at 10am and 11am.
- The clinics will cover the basics of open-water swimming and provide a chance to swim in Lake Audubon.
- There will be a \$10 fee for all participants.
- All clinic attendees must be USMS members.

Eligibility:

- Lake swims and clinics are open to USMS-registered swimmers 18 years of age and older.
- Single-event USMS registrations are available for \$20.

- Full USMS memberships are available for \$32.

Entries:

- On-line entries will be available at Lin-Mark Computer Sports in February 2007. Sign up at www.lin-mark.com.
- Online registration will close at midnight Wednesday, May 9, 2007.
- Mail-in entries must be postmarked by May 9, 2007.
- Entry fee is \$35 for one event, \$65 for two events, and \$90 for three events.
- No refunds will be given.
- There will be no late registration and no registration on the day of the race.
- All entries will be seeded fastest to slowest based on the 1650 Yard seed time entered. Wetsuit and nonwetsuit competitors will be seeded together (no wetsuits will be allowed in the USMS 1-mile championship.)
- All entrants must sign a waiver.

Awards:

- USMS 1-mile championship swim: Awards will be given to the top ten finishers in each USMS-defined age group.
- McDonnell 1-mile swim: Awards will be given to the top three individual finishers in each USMS-defined age group for both wetsuit and non-wetsuit divisions.
- McDonnell 2-mile swim: Awards will be given to the top three individual finishers in each USMS-defined age group for both wetsuit and non-wetsuit divisions.

Rules:

- Current USMS Long-Distance Rules will apply.
- A copy of your USMS card must accompany your paper entry if you are a USMS member.
- 300-swimmer limit per race.
- All swimmers must wear the provided swim cap, a visible race number body mark, and an electronic timing chip.
- A 90-minute time limit will be set for completion of the 2-mile swim and 50 minutes for each 1-mile swim.

Safety:

- Expected water temperature is 66–72 degrees.
- Wet suits will be allowed for the 1 and 2 mile swims, but not for the USMS championship swim.
- Reston Association does not guarantee the water quality
- The course will be marked with buoys.

Scoring:

- Electronic timing and scoring will be done by Lin-Mark Computer Sports.
- Searchable results will be posted on-line at <u>www.lin-mark.com</u>.
- Full USMS age-group results will be posted at <u>www.restonmasters.org</u>. USMS results will be mailed on request only
