

## Lake Monona Open Water Swims 2008 USMS National Championship 2.4-Mile Open Water Swim

Saturday, August 23, 2008, 8:00 AM Lake Monona, Madison, WI

**EVENTS:** 

• 1.2-MileBadger Open Water Swim, 8:00 AM

• 2.4-Mile Non-Championship Classic Swim, 8:30 AM

2.4-Mile USMS National Championship, 8:45 AM

**COURSE:** Lake Monona in Law Park (100 E. John Nolen Dr.) 1.2 mile rectangular course, marked by buoys; "Ironman Wisconsin" course. Swim will be counter-clockwise. In-water start; beach finish.

CHECK-IN: Registration/Check in: 7:00-7:45 am

Warm-up: 7-7:45 am Pre-race briefing: 7:45

**ELIGIBILITY**: Open to swimmers 18 & over as of August 23, 2008. All swimmers must be registered with USMS. You must submit a copy of your 2008 registration card, a completed One-Event Registration Form (\$18), *or* a completed Annual Registration form (\$40). Entries without a copy of the 2008 USMS card or a completed registration form will be returned. ALL ENTRIES: Must be received by Saturday, August 14, 2008. NO RACE DAY ENTRIES.

**FEES:** \$30.00 if received by **August 9, 2008**; \$50.00 if received after August 9. Commemorative T-shirt will be available for \$15.00.

RULES: 2008 USMS Rules will govern this race.

**SEEDING**: Swimmers will be seeded fast to slow according to 500 time in waves of 10 swimmers at 30 second intervals. No-Time entries will be seeded in the slowest waves. Seeding changes will not be allowed after the heat sheet is published.

**TIME LIMIT:** 1:20 for the 1.2 mile swim 2:30 for the 2.4 mile swim. Those swimmers not finishing will be removed from the water.

**TIMING:** Electronic timing chips will be used. Each swimmer will wear an electronic timing chip on an ankle bracelet to automatically record their time. Timing chip must be returned or a \$20 charge will be assessed to the swimmer.

**SAFETY**: Swimmers unable to complete 1.2 mile in 1:20 hour or 2.4 mi in 2:30 are advised not to enter. Swimmers still on the course after the time limit will be stopped and listed as DNF in the results. In case of inclement weather, the race director may close the course and prevent swimmers from completing the swim. The Director of Pools and lifeguards for the City of Madison Parks Department will be directing all rescue personnel. Boats and kayaks will be on the course to provide assistance if needed.

**WATER TEMPERATURE: 72-75°F.** 

WETSUITS may be worn only in the non-championship races.

AWARDS: 2.4 Mile Championship: USMS National Championship medals will be awarded to the top 6 men & women in each age group, 18-24, 25-29, 30-34...100+.. USMS All-American Championship patches will be awarded to the winner of each age group. One-Event registrants will not be eligible for All-American status. Medals will be awarded to the top 3 teams. Event patches will be awarded to all finishers. 2.4 Mi Non-Championship Classic & 1.2 Mile Badger swims: Custom awards to the top 3 men & women in each age group.

**POST-RACE SOCIAL:** The awards ceremony and a social with food and drinks will follow the final heat of the **2.4**-mile race. Free to all swimmers & volunteers and guests under 11 years old. \$5 for guests over 10.

RESULTS: Will be posted at www.swim-wimasters.org by August 30, 2008.

**DIRECTIONS:** I-90 TO Hwy 12/18 West, exit John Nolen Dr (north). The race staging area is in Law Park located on the shore of Lake Monona and immediately to the right after John Nolen Drive passes under the Monona Terrace Convention Center. Contact Meet Director for details. Parking is available, near the race staging area: There is ample parking within the Monona Terrace Convention Ctr., a 5-min walk to staging area.
