What: This is a 1.2 mile rectangular course in the same location as Ironman Wisconsin which is scheduled for the following month. The course is well marked with eighteen orange buoys, patrolled by lifeguards and volunteers in a variety of watercraft. The past water temperatures for this event have been 72 to 77 degrees F.

When: Saturday, August 20, 2011. Event check-in and warm up begins at 7:00 am. The mandatory preswim briefing starts at 8:15 am. You must exit the water after warming up and attend the pre-swim briefing. The swim events start at 8:30 am. All swimmers will start in the water and finish on the beach utilizing electronic timing chips. There will be three starting waves as described on the website. The National Championship event is the first of the 3 waves.

Where: Law Park on Lake Monona,100 E John Nolen Dr, Madison, Wisconsin. Parking and hotels are available in several nearby locations as indicated on the website.

Eligibility: Open to all swimmers 18 years and over as of August 20, 2011. Please judge your own ability level prior to registering for this race. Because this is a USMS sanctioned event, 2011 USMS annual membership is required. Foreign swimmers are not eligible for USMS records or All-American status.

How to Enter/Register: The entry fee is \$30.00 if received before 5:00 pm CST on Wednesday, August 10 or \$50.00 if received before registration closes at 5:00 pm CST on Wednesday, August 17. Paper entries must include a copy of your current USMS annual membership card (no one event memberships allowed) and an extra \$5.00 processing fee. Paper entries must be post marked by Wednesday, August 10 and incomplete entries will not be processed. There will be no registration (including race day) after 5:00 pm CST on August 17. A photo ID (driver's license), USMS membership and event registration verification may be required at check-in. T-Shirts are only available for order with an on-line entry only (not paper).

Safety/Rules: The race course will be patrolled by a variety of water craft and certified lifeguards. Current 2011 U.S. Masters Swimming rules will govern this event and a USMS judge will serve as starter. Detailed safety instructions and USMS rules are included on the website.

Timing: Electronic timing will be used. Each swimmer will wear an electronic timing chip on an ankle bracelet to automatically record their time. Timing chips must be returned after crossing the finish line or a \$30 charge will be assessed to the swimmer.

Cancellation Policy: If a registered swimmer cancels before 5:00 PM CST on August 12, 2011, a full refund will be made less a processing charge. If cancellation of one's entry is made after registration is closed but before the event occurs there will be no refund. In the event that on the established date of MOWS weather or disaster necessitates cancellation there will be no refunds. Participants not in attendance for the event, either cancelled or ongoing, also will not receive refunds of entry fee. Cancellation requests must be emailed to swim.mows@gmail.com.
