## ANNUAL REPORT

Numerous contributions were received by the Endowment this year in memory of members and friends of Masters swimming and in honor or recognition of team or individual accomplishments. A continuation of the "check off" system when paying annual dues will be continued as well as continued efforts to educate our members about the opportunity for contributions to the Endowment. We have not received any grant applications as of the preparation of this report although there have been several inquiries and we expect at least one request before convention to be considered by the Board of Governors. The Endowment has continued to grow through contributions and appreciation the benefit of our relationship with Legacy Fund has proven itself many times over through the elimination of management fees and/or very modest fees. The report through the midyear on the status of the Endowment Fund is encouraging. Since January 1<sup>st</sup>, 2004, we have a reported an increase in the total value of the Endowment Fund to over \$150,000.00 as of June 30, 2004! During the calendar year 2004 we have completed the grant phase approved in 2003 and we have awarded grants of \$4,500 to Bryan Morrison at Arizona State University for basic research on the effect of swimming on aging, and to Joel Stager at Indiana University for the continuation of his research utilizing an accelerometer! Hopefully, both Bryan and Joel will have interim reports on their research at convention.

Finally, many of you knew David Greg, a Masters swimmer from Virginia who passed away this spring during a meet. I hope you had the chance to read the memorial essay by John Feinstein which appeared in the July/August issue of SWIM. It not only honored David's life and passion for swimming, but it offered an excellent explanation of our collective passion as well. Thanks to John for the article and our best wishes to David's family as they learn of the many, many heartfelt words that were spoken by so many about his contributions to swimming and his meaning to them.

## ANNUAL REPORT

The Zone Committee has been busy this year with start-ups of a number of projects. In pursuit of these goals, we have had conference calls from January through July to keep in contact and to move the work along on a consistent basis. I would like to thank the members of the committee for their diligent work and intelligent contributions to the process. We have completed our work for the year and will be able to spend our convention meeting planning for next year.

Projects and discussion that have taken place since the last convention are:

 LMSC Grants Project: Mike Lemke took the lead on this project. This was a start-up project to provide financial support for LMSCs in an effort to strengthen USMS from the local level. We had a \$5,000 fund to spend and decided to implement a limited project for the first year so we could utilize the funds wisely and have a basis for evaluation and expansion for next year. There were two types of grants offered for 2004—convention grants for small LMSCs and special grants for LMSCs to use as seed money to begin programs. Applications were due by June 1, 2004.

This turned out to be a very successful first year with seven applications for convention grants and two special grant applications. We awarded convention grants to Border, Inland Northwest, Midwest, Oklahoma, and Snake River LMSCs. Special grants were awarded to Indiana LMSC to assist in the purchase of equipment for coaching clinics and Michigan LMSC for funding membership promotion. All grants were for partial funding with the LMSCs contributing about half of the cost.

For 2005, the grants will be opened to the Zones for projects intended to assist their LMSCs. The application deadline for special grants will be extended to September 1. During the convention meeting we will be discussing the 2005 program further.

- 2. Election Guidelines Amendments: Lucy Johnson reviewed the current election guidelines and proposed amendments for updates in preparation for the 2005 election. The Zone Committee spent time during several meetings discussing and approving these amendments and adopted the final version at the July 27th meeting. The updated guidelines, with tracking, appear in the convention packet.
- 3. **Communications Plan:** One of the zone committee's requirements is to act as a communication bridge between the national and local level. Rob Copeland has begun to put together a communication plan for the committee to use in bringing national level projects to the LMSC level. The experience we had promoting our grants program will aid in defining this process. Communications will be a major focus for the committee next year.
- 4. **Zone Rep Job Description:** Debbie Morrin-Nordlund is in charge of completing and proposing updates to the job description the committee approved at last year's convention. She has been busy this year developing appendices to attach to the job description which will assist the zone reps in understanding and executing their responsibilities.
- 5. **LMSC Convention Workshops:** Rob Copeland and Lynn Hazlewood connected with Michael Moore (LMSC Chairs group organizer) to set up LMSC workshops for convention. There are five workshops scheduled to begin directly after the zone meetings on Saturday. The local LMSC will provide lunch, to

allow us to maximize the time available for the workshops and your zone reps will facilitate delivery. The workshops planned are: a) LMSC Chairs meeting; b) Managing Corporate Documents; c) SWOT Training for LMSCs; d) Club Mentoring; and e) Communications.

In addition, Minnesota opened its Long Course State Meet held on July 18<sup>th</sup> to the Breadbasket Zone and designated it as the official Long Course Zone Meet, the first one held in the Breadbasket Zone.

Missouri Valley was busy over the summer with 2 events in June, a 1 and 2 mile open water swim held on June 13<sup>th</sup> at Sunnen Lake in Potosi, Missouri, hosted by the St. Louis Masters. In addition the  $2^{nd}$  Annual Old Pike Masters Long Course meet was held on June 22. During July there were two events in the state where swimmers could participate. On July 16 – 18, the Show Me Games were held in Columbus, while on the 18<sup>th</sup> of July, the Sunflower Games were held in Topeka.

Colorado again had a permit to do Open Water Training at the Chatfield State Park in the Gravel Pond from May 15 through September 25th. This is a major undertaking as the pond is open to swimmers on Monday and Wednesday evenings and on Saturday mornings. All sessions require check in and supervision. However, this is such a popular place to train that many individuals are willing to help out. After the previous summer with no Long Course Pool events, this year the Highlands Ranch Master's team hosted their 1<sup>st</sup> annual Long Course Meet in early June. It is hoped that this will become an annual event. During July a second Long Course Meet was hosted by the Squids Masters Team. And also in July, the Evergreen Masters hosted the ever popular Evergreen Masters Golf Tournament. During August, the annual Wingshadow Horsetooth Open Water Swims were contested.

### GREAT LAKES ZONE Zone Rep - Mike Lemke

Nearly all Great Lakes LMSC's appear to be operating smoothly and this summer has again been very active with competition, including the 2004 short course nationals which were held in Indianapolis in April. We conducted interim meetings among the LMSC chairs for the first time (in conformance with new Zone Rep Job Description) and several LMSCs report significant happenings since the mid year report. These include:

**Central LMSC** presented the 2004 CMSA Coach of the Year award to The Wellness Center Sea Dogs coach, Brent Newcomb and the CMSA Service Award to retiring CMSA Registrar, Pat Sengstock; Pat Sengstock, who has been CMSA Registrar for nearly 20 years, is retiring from that role this summer. Marcia Cleveland will be the new Registrar, with Greg Weber taking the title of Assistant Registrar and member of the Registration Committee; Max Zollner has asked to step down from the office of CMSA Treasurer before completing his present term of office. Barbara Delanois has been appointed, with concurrence of the CMSA Board of Directors, to complete Max's term (July 1, 2004 - September 1, 2005).Phil Dodson will be assisting Barbara with the treasurer duties and has been appointed as Chair of the new Finance Committee.

**Lake Erie** reports registrations ahead of last year and will be happy to have 6 at convention. The budget is in the black and things are going well.

**Indiana** - Greater Indiana Masters Swimming (GRIN) held its annual state championship meet at Avon High School on March 26-27, 2004. It was a huge success and remarkable for its growth. Participants in the meet numbered 232, vs. 160 in 2003. This represented 18 teams primarily from Indiana, but with representatives from Ohio and Illinois. During the break, the Irv Merritt Memorial Award, GRIN's highest honor, was given to three worthy recipients for their years of service to masters swimming: Melissa Rinker, Cheryl Gettelfinger and Diane Sidner. Two GRIN members, who continue to compete, will attain 80 years of age this year and were granted Lifetime Member Emeritus status: Dr. Cory SerVaas (F75-79) GRIN Emerita; and Doug Strong (M75-79), GRIN Emeritus. Eleven individual and two State records were set.

Recent meets in Indiana included the Indiana University Masters (DOC) Meet in Bloomington on Feb 14, 2004, and Michiana Masters (March 21, 2004) in South Bend. The 10th Annual NASTI/GRIN Fitness Series concluded with a Leap Day swim on Feb 29, 2004. The SCY National Championship Meet (April 22-25, 2004) was a huge success and can be read about in the July/Aug issue of SWIM Magazine, Vol XX (4) along with the

tribute to Doc Counsilman. The two-mile cable National Championship was held on a beautiful June 27, 2004 at Eagle Creek Park in Indy. Results are on the web at GRINswim.org and USMS.org. Also successful were the Fall Classic (zone champion-ship) at IUPUI, the Fitness Series, and the Indiana participants in the January One-Hour Postal swim was large and enthusiastic.

After the success of our "snooper clinic" in June 2003, GRIN purchased a snooper camera of its own and has since provided it free of charge to any USMS member or club registered in Indiana. The snooper has been used in clinics in January at the One-Hour swim (NASTI/GRIN Fitness Series), in March at Healthplex Masters in Indianapolis and in Avon at our state championship meet. Another clinic is scheduled for northern Indiana in July 2004. We hope to upgrade this with a Tivo system in near future. These clinics are fun and provide real value to membership in USMS.

Last year's (2003) convention in San Diego was fruitful. The Indiana contingent was comprised of 8 conventioneers: Dick Sidner, GRIN Chair; Cheryl Gettelfinger, Vice Chair; Doug Church, USMS Treasurer; Randy Crutchfield, Treasurer; Jim Lewis, Registrar; Joel and Nan Stager (Coaches Liaison and Sanctions) and Melissa Rinker (Marketing). Due to transitions and training, in September 2004, we will take a record 11 individuals to Convention in Orlando: the entire cast above, plus Dannyelle Mitchell (Registrar-in-Training); Raena Alexis Latina (Newsletter Editor); and Dave Oplinger (Web Master).

Alan was riding his bike near Santa Rosa on April 11, 2004, training for the Wildflower Half-Ironman Triathlon, when he was struck from behind and killed by a drunk driver. He was a dedicated coach, an enthusiastic teammate, and a good friend.

<u>Pacific LMSC</u> has a full swim calendar in all courses for 2004. Many National and World swim records have been set this past year, and many with Top Ten Times in all three courses.

Santa Cruz Masters again hosted both Short Course and Long Course Championships with over 800 swimmers attending the 2004 Short Course Championships. A photo was taken from the roof with just about everyone in the pool. The Long Course Championships will be held after this report goes to press. Thanks and congratulations to Joel Wilson and Paul Wrangell (Cruz) and all the supporting staff for well run meets.

Coaches Report: For the 2004 and 2005 seasons, the focus for the Pacific Masters Coaches Committee will be "EDUCATION AND COMMUNICATION". Put into work already this season have been scholarships opportunities for coaches to attend the annual Pacific Swim Coaches Clinic every January in Napa, the clinic provides presentations from the best- known coaches within the entire swimming community and specific Masters tracs to address the unique needs of our sport. A one-on-one mentoring program is available for those coaches or teams that could benefit from some of the more experienced coaches within Pacific Masters. PMS provides funding for a team to hire substitute coaches for their program as their coach shadows a mentoring coach at his program for a day, and a small stipend to the mentor coach. Brian Stack and Kerry O'Brien plan to have a Comprehensive Fitness clinic (broken out from the Napa Clinic) in late November at The Olympic Club

new pool. Pacific Masters had taken a successful page from the USMS Coaches Committee and is adopting an on-deck coaches program for our regional championships. Other opportunities include observing and sitting in on swimmer/coach video assessments during the Walnut Creek Masters Intensive Training Camp in March, and being involved in the quarterly PMS Coaches Retreats where ideas can be shared and concerns can be heard. We hope this will develop into one of our more promising ventures. Pacific will be represented at Convention this year with 21 delegates and 9 automatic delegates.

<u>Hawaii LMSC</u> – The Hawaii LMSC membership is down slightly from last year, but they have a lot of first time members. Diane Stowell is visiting the various clubs on Oahu to work with them in educating them on USMS, and the various benefits. Hawaii does have two new clubs on Oahu that have registered this year. ## Workshop #3—S.W.O.T Training Meeting Room – <u>Exhibit Hall C</u>

The SWOT workshop will be led by Rich Burns, who provided the following information on the workshop's purpose and agenda:

The USMS Marketing Committee is embarking on a program to assist LMSCs in enhancing the effectiveness of their marketing programs. Working with Adirondack LMSC, the committing is implementing a pilot program incorporating a strategic marketing process developed for the Executive Committee. A key step in the process is an analysis of the LMSC's strengths, weaknesses, opportunities and threats (SWOT).

This hands on, interactive session will describe the nature of a SWOT Analysis and then proceed to conduct an analysis that will comprise the first step for the Adirondack LMSC. Mary Field, LMSC chair will represent the Adirondack in identifying the SWOT elements. Since most LMSCs share similar concerns, the session

will explore the issues that impact LMSC marketing and management. The results of the SWOT evaluation will then be evaluated, and the session will demonstrate how the SWOT elements can be turned into an action plan. The specific conclusions will provide Adirondack with a program for proceeding with their marketing planning.

The session is relevant to all LMSC representatives. It also will provide a valuable framework and take away usefulness for any group within USMS (zones, clubs, committees, etc) in the future planning of their activities. We invite participation by all delegates in assisting in this important first step in the pilot marketing program.

A SWOT Analysis is a benchmarking process used in strategic and marketing planning. Internally it delineates *strengths and weakness*, and externally it identifies *opportunities and threats*. The SWOT Analysis is conducted to identify the attributes and virtues of the organization that can be the focus of the marketing program, and to understand the deterrents and obstacles to the organization's or marketing programs success. A thorough SWOT Analysis is incredibly revealing in identifying and defining the major issues confronting an organization.

#### Strengths

Strengths are internal attributes of the organization that make it different and special. They can include the structure, people, resources, history, accomplishments, values, programs, size, geographic presence or anything else that empowers the organization to excel in its purpose and mission. The list of strengths provides guidance on the resources and capabilities upon which to build the strategic marketing program.

#### Weaknesses

Weaknesses are also internal and are self imposed limitations and problems that are negatively impacting the organization. These are typically the same categories as strengths but that are not in favor of the organization. The challenge, once weaknesses are identified, is to mitigate them.

#### **Opportunities**

Opportunities are situations or conditions that exist outside the organization. Opportunities for USMS could include size of market, facilities, alliances with other organizations, education etc. Opportunities must be aligned with strengths to determine how best to capitalize on them.

#### Threats

Threats come from outside the organization. Threats, like opportunities, vary in their magnitude and longevity. Some can be mitigated through the development or marketing program. Others may be permanent. Threats could include competition from other programs (YMCA, health clubs etc.), transient membership, etc.
