### Why are you interested in this position and why do you believe you would be a good candidate?

I believe that USMS needs the leadership I am prepared to give. A good leader gives credit and takes responsibility. I have a plan and a vision that is simple, clear, and consistent. Not big changes, but changes that will make a difference.

# What do you consider to be the major issues facing USMS now and in the future? As a person holding an elected position within USMS, how would you address these issues?

Membership stagnation is one. I would encourage a national advertisement and media campaign, including support for nationwide free swimming lessons for adults. Programs that may be wasting time or money that could be better used elsewhere need to be reviewed. Membership dues rise without apparent need or commensurate services. New membership will remove the need for more increases. There are vast areas of the country without Masters programs, I want to put clubs everywhere that there are pools and people to use them. The administration of USMS needs to be transparent, including the operation of the National Board of Review. I would stop sanitizing BOD minutes and post activities of the NBR. National committees need more time face to face in order to create understanding for their emails and conference calls. I would not only give them more meeting time at convention, but end the convention day at 5 pm, stop scheduling unopposed meetings and reduce the number of HOD meetings to those that are necessary. Insurance premiums are ghastly, we should reposition ourselves to reduce the apparent risk in operations and promote our safety record.
