## Minutes

The meeting was called to order at 8:02 p.m. eastern

1. Chair Welcome

Scott Bay-Welcome to 2014 coaches committee. We are very active and involved in a lot of projects

How we operate as a committee is that subcommittees divide the work for us and report out to the full committee. We are the leader in coaching knowledge in USMS Swimming. Please contribute one article to Swimmer, SLC or SLV throughout the year. We also expect everyone to be at convention. We need to organize workout groups for Convention, on deck coaching, etc.

2. Discussion of Bringing Certification in House

Scott-We have developed the course and have given the course, but ASCA has always graded the course. We are looking to now bring everything in house.

Bill- We are now capable of managing it in house to either mail the test to USMS or an online test to take. There is a cost involved, who has to pay for this? The cost would be the same as it is now.

What is the value of an assessment? Do we want to do one? Consensus of the committee was yes.

\*70% of the people who take the class do not turn in the test to ASCA currently.

\*Looking into January 1<sup>st</sup> launch date into bringing the class assessments in house.

Bill is going to come up with two options for a test for 1 and 2. Online test or to pass a test out at the end of class.

What is the recognized coach piece?

Certified Coach- Must take one of the classes. It is a statement of one's credentials. Recognized Coach- Must sign up online when registered for USMS \$30 fee on top of normal fees. It will always be an option, not mandatory. This will be an additional benefit to being a coach

- 3. ON Line Coaching Update
  - a. Erin Mathews- Publish in streamlines for online coaches this month that we are accepting applications for the open positions. We need to get the word out so people can put in their applications. We have three openings for 2014. A subcommittee headed by Erin will pick the new coaches.
