- Relay results cause biggest uploading issue due to incorrect age groups or illegal multiple club relays.
- John Kenny meet in Oct does not use an automatic timing system (i.e. watches & a spreadsheet). Required to manually enter all times for USMS members.
 - If the meet grows they will need to look into a Dolphin system or something like that.
- Need to be diligent on Observer reports for Recognized meets. Required for top-10 to be official.
 - \circ $\,$ No issues this year, but needed for French Creek & SJAC meets.
- Need to be sure meet directors are printing out forms for timers. When the pads don't work we need a record (La Salle was an issue).
- (Not required) Encourage swimmers to put in split requests before the event has been swum just to be certain we have 2 watches on the split in case of timing issues.

Highlights

- DV Coach statistics
 - 79 Delaware Valley swimmers identified as coaches in 2023 registration.
 - This is a decrease of 75 swimmers from the 154 swimmers who identified as coaches in 2022.
 - 33 Delaware Valley coaches have achieved some level of USMS coaching certification, which is an increase of eight certified coaches over 2022:
