Minutes

I. USMS Treasurer's Report

Jeanne Ensign reported that our cash and cash equivalents as of 9/15/99 are \$785,610. There was some discussion as to whether some of the USMS cash reserves should be used for USMS committee projects, or possibly into the USMS Endowment Fund. Another suggestion was to investigave an increase to our insurance reserves (in furtherance of a self insurance concept) as a way of reducing insurance premiums.

II. USMS Controller's Report

Suzanne Rague presented the USMS Controller's report.

Registration revenue – the Controller discovered variances, and possibly underpayments, by some LMSCs that were a couple of years old, for a total of approximately \$6,000.00. She proposed that the oldest of these be "written off" by USMS, so that we can start with a clean slate in 2000. MSA that the Finance Committee forgive the 11 LMSCs with a cumulative variance of approximately \$1300.00, and that the Controller further investigate the larger variances.

MSA to recommend to the Legislation Committee to accept Suzanne Rague's proposal to keep the Internal Auditor as a member of the Board of Directors and authorized Suzanne to write the appropriate language to submit to the Legislation Committee.

III. USMS Internal Audit Report

June Mather is the new USMS Internal Auditor. She suggested that the National Office send a registration report to each LMSC Registrar quarterly. Jeanne Ensign responded that a report has already been created, and it will be mailed out monthly to each LMSC Registrar, whether the Registrar has made a submittal that month or not.
