At the time of his death, Irv's family established an annual award in his memory to be presented to an Indiana Masters swimmer who exemplified the standards and values embodied in the life of Irv Merritt.

Ivan Chalfie and Robert Badger were named Emeritus swimmers. The distinction is given to long-time swimmers who are at least 80 years old. GRIN will pay their dues from now on. Both swim for YMCA Indy SwimFit.
