  - Who comprises the IMSHOF selection process committee? (7 members). Specifically who was not known by Bruce.
  - How are the IMSHOF candidates selected? Other than pool swimmers, the selection is based on biographical information with emphasis on **international experience.**
- A discussion of where to hold the IMSHOF ceremony ensued because of the financial burden it has placed on the Hall of Fame. It was MSA (Motion: Carolyn; Second: Barbara) that the 2007 IMSHOF Induction Ceremony be conducted at the Anaheim convention with the cooperation of the Convention Committee, and corporate sponsorships, with a USMS – ISHOF collaboration.
