Banquet Report:

- A total number of 70 attendees plus Special guests Mr. & Mrs. Bruckner Chase

    - Per email response from USMS, the launch of Salesforce CRM (February 2022) will be the catalyst for greater functionality, including things like gift memberships. There is no estimate on how long it may be before it is available but it is on the USMS IT backlog.
    - Did we disable the ability to apply a discount via the USMS registration system? USMS disabled that functionality when we transitioned to the unified fee.
