

Ad Hoc Officials Committee Minutes, September 20, 1990

1. Meeting was called to order by Sally Ann Dillon 9:00 AM.
2. Members Present: Sally Ann Dillon, Chairman; Rick Windes, recorder, Jayne Bruner, Pat Diehl, Judy Gillies, Janet Kavados, Mark Lambert, Dick Monahan, Adrienne Pipes, Larry Rice (USS), Edna Spring
3. The committee's Aim was changed to read as follows: "The Ad Hoc Officials Committee aims to have all USMS sanctioned events officiated by competent officials on a uniform basis throughout the country applying all USMS rules, at all levels, and at all meets."
4. The committee recommends that each LMSC establish an Officials Chairman who will--on a continuing basis--develop and maintain a liaison with counterparts in USS/YMCA to include keeping a roster of qualified officials willing to work at Masters meets and maintaining a schedule of officials clinics.
5. Questionnaire on officiating procedures was mailed to 59 LSC chairmen on June 25, 1990. 17 responses were received. Committee will release a follow-up questionnaire to remaining LSCs.
6. Supplement: Appendix E to USMS Rules, Differences between USS and USMS Rules. A subcommittee consisting of Pat Diehl and Dick Monahan will design a wallet-sized supplement for distribution through USMS to USS/YMCA officials. A second subcommittee consisting of Judy Gillies and Jan Kavados will rearrange and highlight Appendix E. The committee recommends that Appendix E continue to be printed on facing pages in the Rulebook for ease of photocopying, and also recommends that LMSCs include a copy of Appendix E along with each sanction approval mailed to meet directors.
7. Article for USMS Newsletter. An article on officiating concerns will be submitted for publication in the USMS Newsletter. The committee agreed to submit the article in the outline format for greater impact. After some spirited discussion, warmup guidelines in the article were changed to emphasize NO DIVING during warmups.
8. Guidelines for Warmups. The committee recommends that LMSCs obtain the USMS Guidelines for Warmups and send copies of these guidelines to meet directors.
9. Before adjourning at 12:10 pm, the committee noted that officiating procedures vary widely within USMS, and USS/YMCA. Such variations will undoubtedly keep the committee quite busy in future attempts to achieve its Aims.


