- 3. Discussed standardizing the process for an officials qualifying meet application for N2/N3 certification, and posting to the USA-S & USMS web sites in a timely manner.
- 3. Adopted LMSC Minimum Officiating standards to represent best practices and standards for measuring LMSC progress in developing the local USMS officials.
- 4. Discussed the revised USMS certification standards. MSA to amend the standard under the full certification section for stroke and turn judge, starter, and referee to deleted "non-championship" and replaced with "LMSC" in each of these sections. MSA to adopt the revised certification standards as amended.
- 5. Discussion of the requirement to take the USA-S Officials Tests, which require the use of a USA-S Rule book for reference, and will need to work with USA-Swimming to determine how best to make it relevant the USMS Rule Book.
- 6. Discussion of Rule Proposals:
 - R30/R31 either one of these could have an effect on Administrative Officials.
 - The committee recommends withdrawal of R54.
- The committee noted that there is not longer a FINA Officials list for masters. Our committee would like nominate officials to attend the FINA Masters World Championships. There will be ongoing discussion of this process with the FINA Masters Liaison Nancy Ridout.
- 8. Charlie Cockrell summarized the annual LMSC's Reports.
