Subcommittee Reports:

1. Open Water Development & Promotion Subcommittee. Purpose: To generate real, actionable ways to develop and promote open water swimming. This is the central purpose in the committee definition. Chair & Members: Chair: Will Reeves. Members: Denise Brown, Lynn Hazlewood, Jim Kennedy, Karen LeFebre, Joe Linford, Andrew Magazine. Report/Discussion: Will reviewed his message to the subcommittee members and used that outline to lead discussion. Topics were...
 - Communication, specifically a channel to LMSC Chairs, Open Water Chairs, & Event Directors;
 - Peer-to-Peer conference, led by the USMS LMSC Development Committee;
 - Promotion at various levels;
 - Open water practices: Standards, guidelines, insurance, promotional value, counting swimmers who participate, counting them as ‘places to swim’.
2. Open Water Guide to Operations (OWGTO) Subcommittee. Purpose: To review, revise, format, and communicate the contents of the OWGTO. Chair: Bob Bruce. Members: Becky Cleavinger, Lynn Hazlewood, Eric Hektner. Report: None (ran out of time).
3. Rules & Legislation Subcommittee. Purpose: Working as a joint subcommittee with members from both OWC & LDC, examining & vetting rules proposals and bringing these proposals for consideration to the OWC then the LDC (although proposing rules to the USMS HOD is an LDC function, we have chosen in recent years to have this group work across both committees for thoroughness). Chair: Bob Bruce. Members: Becky Cleavinger, Lynn Hazlewood, Will Reeves. Report: None (ran out of time).
4. Safety Education Subcommittee. Purpose: To review any new or ongoing business to the OWC relating to safety, and to review the documents and process of safety planning with the Open Water Safety Advisor. Chair: Bob Kolonkowski. Members: Kim Elsbach, Rory Grigull, Jim Kennedy, Peter Lee. Report: Bob K. will have a report in April.
5. Event Management Subcommittee. Purpose: To prepare material for seamless presentation of events and to develop the training a course on event development & management for Event Hosts/Event Directors (first piloted in presentation in 2015). Chair: Karen LeFebre. Members: Jenny Hodges, Joe Linford, Helen Naylor. Report: Helen reported on the clinic to be held in Knoxville, TN, with the national championship event, with the hope that this will provide a chance for our clinic model to be tested and an opportunity to work together with the Long Distance Committee. Logistics for clinics at national championship events are a concern. Bob B. reported that he is working on a comparison of open water rules among USMS, USA-Swimming, USA-Triathlon, and WOWSA, which has implications for rules and event management.
6. Officials Subcommittee. Purpose: To evaluate current practices in officiating USMS open water events and to develop materials to improve this. Chair: TBD. Members: Rory Grigull, Peter Lee, Helen Naylor, Will Reeves. Also Jim Davidson from the LDC. Report:
7. Awards Subcommittee. Purpose: To manage the process for selecting our annual Open Water Service Award, and perhaps exploring the honoring of USMS open water “pioneers”. Chair: Jenny Hodges. Members: Bob Kolonkowski, Will Reeves. Report: None (ran out of time).
8. Open Water Swim Training Subcommittee. Purpose: To develop guidelines and materials for coaches to prepare swimmers for open water swims. I hear that the Coaches Committee is considering adding such material to the Coaching Certification program, so we may have an opportunity to work jointly with this committee. Chair: Mark Johnston. Members: Denise Brown, Kim Elsbach, Jim Davidson, Andrew Magazine, Helen Naylor, Kate Stephensen. Report: Mark & Helen reported progress on this project.
