## Minutes

1. Chair recognized Marianne Groenings from NO to discussed educational opportunities and programs. Also introduce Steve Hall volunteer coordinator
2. Bruce gave a zone update.
  - a. Discussed LMSC standards
  - b. Discussed the Border LMSC and its boundaries.
  - c. Discussed NT contribution to convention
  - d. Discussed SC zone hosted LMSC summit
3. The Chair recognized the Jesse Coon Distinguish Service award. Susan Ingraham
  - a. Bruce requested each LMSC to put forward 2 Jesse Coon nominees next year, by December 25, 2017.
4. Bruce Rollins was nominated and elected as SC Zone chair. Nicole Rembach was nominated and elected zone vice chair.
5. Reviewed 2017 zone meets:
  - a. SC Zone meeting at Woodlands: Attendance was good but not as high in the past. Meet made money.
  - b. LC zone at Texas A&M: Got good information from the post meet survey. High response rate to the survey. Attendance was down from prior year. Meet had a deficit. LMSC chairs will discuss offline a plan to reimburse this deficit.
  - c. Discussed the maximum time standards and if we want to keep the standards for distances down to 200 or more. Tracy Virant discussed the need for ADA compliant pools for competitions and gave a few examples. Discussion followed. No action taken.

6. 2018 zone bids:

  - b. Texas A&M – Long Course Zone July 6-8, 2018
  - c. Discussed bids for 2019 SC zone meets. MSA to hold a conference call in January 2018 to finalize zone meets in 2019.
