WMSC Committee Chair Reports

Sanction Chair - Melinda Mann

- Wisconsin Masters sanctioned 9 Pool and 1 Open Water event this past season.
- This was the first year for Wisconsin to host a masters open water event.

This year meet directors were instructed to submit all meet documents to the Sanctions Chair prior
to requesting a sanction to ensure accuracy before publication. This step was initiated because of
the difficulty encountered when trying to make changes after an event was already sanctioned.

Registration Chair – Julie Paque

The membership coordinator position has radically changed this year. The majority of the registration tasks are now done by the National Office. It was not a smooth transition. I now have the following duties:

- Answer members' questions and explain how to make address changes, etc. online
- Fill out transfer request form for National Office to process
- Obtain one event spreadsheet from meet directors and forward to National Office
- Send out emails to members

We need to determine how to handle the comped registrations, since I can no longer register or renew members. Also, if anyone needs stamps for WI Masters business, see me before purchasing any. I did not realize I wouldn't be sending out thank you letters to those donating money, so I have extra.

Open Water/Long Distance Chair - Jennifer Vallo

Wisconsin Masters Swimming hosted a new sanctioned open water race, The WOW Swim (Wisconsin Open Water Swim), on Saturday June 24 at Fox Brook Park in Brookfield, WI. We had 70 registrants, 50 participants and plan to make the race an annual event.

USMS sponsored the following Open Water National Championships in 2023: June 3: 2-Mile Cable-Charlottesville, VA July 9: Ultramarathon Distance-Portland, OR July 15: Marathon Distance-Applegate Lake, OR August 12: Middle Distance-Lake Oahe, SD September 16-17: Long Distance-Mission Viejo, CA September 16-17: Sprint Distance-Mission Viejo, CA

USMS Open Water National Championships scheduled for 2024: dates tbd USMS sponsored several virtual and fitness events throughout the year to help keep us motivated and in the pool.

USMS will again sponsor ePostal events for 2024: January 1-31: 1-Hour ePostal May 15-September 15: 5k/10k ePostals September 15-November 15: 3000/6000 ePostals

I reviewed the monthly financial reporting packages and the year-end financial statements which are submitted to USMS. I also filed the Form 990-N with the IRS and completed the annual report for the WI Dept. of Financial Institutions.

Coaches Rep - Fred Russell

A few new accomplishments for the past year:

- I was contacted to help several new workout group coaches. I had a few new coaches ask me questions and I answered them. For a couple others, I contacted or tried to contact them for various topics from attending meets to getting certifications.
- Worked with two new WISC National Coaches, Josh Lefeber and Anne Berres-Olivotti.
- Returned me (since 2019) to the National scene to both Irvine and Sarasota.

Finally, I continued to send out emails of three workouts a week to about a hundred contacts. (These have been really important to swimmers who train alone or small groups without a coach).

3. New Business
