EXECUTIVE COMMITTEE MID YEAR REPORTS

PRESIDENT Jim Miller, MD (also includes International Liaison and USAS Representative reports)

I have had the honor in representing USMS in many of the United States Aquatic Sports meetings. We are receiving more attention due to our bid to FINA for the 2006 World Championships. I have a meeting in Chicago the weekend after Tempe, dealing with this and other topics. I am also in communication with the other aquatic disciplines to determine their needs for a world class event. This bid will include Masters Water Polo, Synchronized Swimming, and Diving.

I also represented USMS at the opening of the Masters Hall of Fame in January. This was the first induction ceremony which recognized all those Masters who were already in the ISHOF. Masters will continue to be inducted into the ISHOF at a rate of 2 per year for all aquatic sports and all nations. The Masters Hall of Fame will not have this limited number of inductees per year. Todd Spieker has done a fabulous directing the opening of this hall.

I serve as the moderator of the Data Base Task Force. The members of this task force have spent untold hours directing USMS along a path that will make the communication within our organization much easier. I feel that we owe it to our volunteers to make their jobs as easy and streamlined as possible. The permanent ID numbers went into effect this year. As our experience with this system grows, we may be able to look at truly permanent numbers that do not have a dated component. At this time the constant movement of members in and out of USMS makes it difficult to keep up with them without a date related component.

The theme of last year's convention was to initiate the process of linking committees with similar themes so that they would see their similarities and begin to forge links between them. We recognized that projects such as FINA Worlds will take considerable joint tasking to be successful. This year we will take that theme the next step and configure the convention so that these teams of committees will be able to continue to work together by aligning them so that they do not conflict within the teams. The available committee time has been substantially expanded in response to the feedback that we received last year.

Finally, I would like to thank the other members of the Executive Committee as well as our national office and our Legal Counsel for the incredible job that they do for all of us. As the burdens of leadership increase, their personal sacrifices also increase to meet the demand of leadership.

Once this handbook is completed, it is put up on the USMS Website (thanks Web Jim) and a hard copy is sent to all LMSC Chairmen and Registrars. This year, the electronic Word file was sent to Meg Smath, Chair of the Publications Committee who will review the entire handbook for quality and content and make recommendations for what needs to be done to make it more complete.

The above are the bigger projects that need to be done before the end of the year. Every day there is e-mail, phone calls mail and faxes that need to be answered.

Monthy we have registration transmittals. As you will see below in Esther's report, she takes care of the actual membership database and creates some "nifty" reports with the data. I am responsible for the receiving the payments, making the deposits, creating individual reports to be sent to the LMSC Registrar and Treasurer and monthly reports that are sent to the USMS Treasurer, Controller, Finance and Registration Chairs. This office (with the help of my assistant – Hilary) also maintains the Club database, create the Club certificates and send out the Club rule books. I also maintain the LMSC Officer Database, with the assistance of Michael Moore and Jim Matysek.

- Streamlines... from the National Office our quarterly newsletter which is sent in October (includes the review of Convention thank you June Krauser), January, April (includes the mid-year reports) and July
- Publication orders filling the orders and maintain the inventory
- Address Changes we average over 3,000 per year!

I am also part of the Executive Committee (a voice but no vote) and have participated in their conference calls and the mid year meeting in Phoenix. I am a member of the Database task force and have participated in their various conference calls. I have most recently been included in the International Committee conference calls concerning the bidding of the 2006 FINA Masters World Championships.

Well, I guess that is about it. I'm sure I have forgotten to list a few things, but I think this report is long enough. I can guarantee, that whatever they may be, I do get them done!

USMS DATABASE ADMINISTRATOR Esther Lyman

Mid-year is always a welcome milestone in the member registration area. The main crush is behind us -- renewals and new swimmers coming onboard in time for the SCM meets in December, the Hour Swim in January, and the regional and national championships. So is the verification of swimmers for Top Ten, the Hour Swim, and All-American lists. And not to forget, the bi-monthly mailing list for SWIM, vendor lists, and lists for competitive activities, before and after. We now have time to do more of the 'pruning and tuning' necessary to make sure reports are generated based on quality data, feed our archives, and do ongoing maintenance.

The addition of the permanent ID to the membership number seems to have been incorporated painlessly (mostly :-), and even transfers from one association to another are working out smoothly. With the major upgrade in the registration software and the necessity to perhaps actually read the manual, both established registrars and our many newbies (to the process or the software, or both) have found that many of the available functions can help streamline their work. Although donations and one-event fees are not membership money per se, they still come in the same batch and need to be accounted for together. With the new, improved summary transmittal report (Thanks, Leo), which captures all incoming monies, we can match them against the checks. Some registrars have just 'discovered' the ability to have the software track donations and one-event swims. Capturing one-event information electronically instead of just on paper makes it easier to keep back-ups of the information, and perhaps do follow-up recruiting.

(Electronically stored information can be 'searched on' and aggregated/manipulated easily.)

DATABASE ADMINISTRATOR, continued

This is our 4th year of having good data available for analysis, and the pattern for renewals/new registrations seems pretty consistent from year to year. Based on actual registration dates (with a few variances, but not enough to skew the numbers), the memberships dated before April, break down like this: (note, percentages are based on previous year's total membership)

As of mid-April, we have booked 32,769 members with registration dates through April, or 77.7% of the 2002 total of 42,177 gross registrations (transfers not screened out). We would need to register an additional 9,408 members to equal but not exceed that number. *Note, however, that April is only partially submitted and we may yet receive some from March. Still, there seems to be a downward trend we haven't caught up with so far.

DISCUSSIONS AND PROJECTS THAT HAVE TAKEN PLACE SINCE THE LAST CONVENTION:

2003 SCY Nationals at Arizona State University in Tempe, Arizona: Carolyn Boak is the meet liaison for the Arizona nationals and Debbie Cavanaugh is the liaison in training. We currently have 1915 swimmers, which will make this the second biggest nationals we have had outside of Northern California. On-line entries are now up to 73%, which saves the Host a lot of time. The meet will be deck seed. However, we are trying something new this year. By having swimmers check in the day before, we will have heat sheets available for the swimmers each morning except for the distance day. The meet host is also having a party for all Gold Medal Sponsors.

2003 LCM Nationals at Rutgers University in Piscataway, New Jersey: Jerry Clark is the liaison for these nationals and Lisa Watson is the liaison in training. This meet is not too far from Baltimore, where we had a record setting 1380 swimmers for Long Course Nationals in 2000. Therefore, we are having a five-day meet instead of the standard four-day meet. The meet will be deck seed and heat sheets available for the swimmers each morning except for the distance day.

2004 SCY Nationals in Indianapolis, Indiana: Sandi Rousseau is the meet liaison for Indy.

2004 LCM Nationals in Savannah, Georgia: Lisa Watson is serving as the liaison for Savannah.

2005 National Championship Pool Venues: Jeff Roddin has sent out a letter to major aquatic facilities encouraging them to consider biding for either of our championship meets. He is in the process of sending out letters to the local LMSCs requesting that they encourage potential host to bid.

2005 Bids: Possible interest from Coral Springs, Florida (short course), Orlando, Florida (short or long course), Sarasota, Florida (short course), and Mission Viejo, California (long course).

Entry Processing Workbook: Sandi Rousseau has completely updated our Entry Processing Workbook. This workbook assists the host in adopting a consistent process for handling meet entries and anticipating the type of inadequacies and problems to expect when processing entries.

ACTION ITEMS:

Telephones at Nationals: We changed the contract section to reduce the number of telephones required due to the widespread use of cell phones:

There shall be adequate public telephones available, convenient, and in working order during the meet. For the first 1000 entrants, there shall be one phone per 500 entrants; thereafter, there shall be one phone per 750 entrants unless otherwise approved by the Championship Committee.

Officials at Nationals: We revised the contract section to reflect our policy agreement with USA Swimming with respect to using our national meet as a Championship Certification meet for officials.

TASKS FOR THE MONTHS LEADING UP TO CONVENTION:

Meet Liaison Handbook: Over the past few years, the job of meet liaison has become much more complicated. We now have a four-page outline of topics that we cover with the host during the pre-meet site visit. Carolyn Boak has volunteered to write a Meet Liaison Handbook that will describe everything that the meet liaison needs to do to make sure that we have high quality national championships.

LCM Qualifying Times: We are putting a committee together to explore new ways of calculating National Qualifying Times for Long Course Nationals. The qualifying times for Long Course have always been must easier to achieve than those for Short Course. Also, the current method sometimes results in a faster qualifying time for an older age group than for the previous age group.

Nationals Meet Information in SWIM: We are putting together a committee to determine what needs to go into SWIM magazine so that a swimmer can enter and attend a national championship. All other information would then go on the USMS website and/or be provided to the swimmer at registration.

OPENING PARAGRAPH:

The Fitness Committee feels confident that we have been successful in enhancing the quality of Masters Swimming for the non-competitive member. Judging from the people who approach me at swim meets to talk about Virtual Swims or articles on the web, it seems we are offering a variety of activities and information for the competitive swimmer also. We continue to see more involvement by Committee members as each month progresses.

DISCUSSIONS AND PROJECTS:

Our projects since the last Convention have been to use the newly renovated Fitness section of the USMS Website for communication, information, and to launch our three new Fitness events. Thanks to Bill Volckening for all the work he has done in this area. We have successfully posted the three new Fitness events. The Check-off Challenge is an event that runs through 2003 but the t-shirt sales concluded in December. This event sold 177 T-Shirts and made over \$600 for New England Masters. They are willing to donate part of the \$200 event start-up stipend to advertising for all three Fitness swims. (i.e. an ad in the Nationals Heat Sheet).

The Virtual Swim Series and the 30 Minute swim were completely posted on the web on January 15. This was two weeks later than originally planned. The Crawfish Masters of Louisiana created a swim of Lake Pontchartrain and offered shirts for sale to coincide with their team swim in January. The deadline to order a shirt was Feb. 15. They had 20 out-of-state orders. This is fantastic considering the Virtual Swims were only posted a month before the deadline. There is much evidence that many people are doing them from e-mail questions and suggested corrections, but we won't know for sure until the end of the year. There are eight swims posted on the web and the ninth, a swim of the Erie Canal, is finished except for finding a good map of the 40 miles of canal. The 30 Minute swim is being hosted by PNA. I have heard that many coaches will be doing this as a team event, especially in the fall to lead into the Hour Swim. Again, numbers won't be known until the end of the year.

The Articles of the Month have been successful and we are seeing more committee members get involved in this area. Committee members each volunteered for a month through September.

ACTION ITEMS:

We will solicit nominations for the 2003 Fitness Award and gather volunteers from the Committee to host the Fitness Events for 2004 so a vote can be taken at convention.

This reports on the work of the History & Archives Committee during the past six months. This report is on-line with links at <u>http://www.swimgold.org/committee/midyear2003.htm</u>.

Our most important task has been to get underway with the conversion of our databases to SQL for which we received a mandate and budget of \$18,000 from the HOD 18 months ago. During that time we've written three proposals and worked with the Database Project (established by the Executive Committee) to determine the best way to proceed. At this point it has been decided that the USMS webmaster would take over our RFP and the first contract is about to be signed with a consultant. The database committee decided (and the EC affirmed) that H&A maintenance procedures will not be preserved, so our committee will no longer serve USMS in the creation and maintenance of major databases. We will instead work with the webmaster in the development of procedures whereby stories, oral histories, historical documents and photos can be continually integrated into the enterprise database. Meegan Wilson will represent us in that effort. There will continue to be issues requiring research and Barbara Dunbar will lead that part of our effort.

Now that the conversion of our data is underway, our biggest project will be to annotate and catalogue our images. We have been gathering photos of our swimmers for several years. We have more than 3200 photographs at this time (not including the USMS calendar project in the late 80's). Our top priorities for this project are; first, to use what we've learned to improve the quality of our images and their presentation. Mel Dyck, Meegan Wilson and I will be taking the lead on this. Our second priority is to create a database of annotation so we can search for photographs and find good documentation for them. Wayne Smith, Katie Cooper, Howard Rutenberg and Debbie Cavanaugh will be improving our

annotation while I will manage the development of the database. We are learning ways to present photos with their annotation. For examples, see the Top Ten Photo Gallery and USMS/USAS Convention 2000 photos.

While we don't have the legal right to use many of our photos without getting permission from the photographers, the photos are being preserved and will be available on a restricted basis at ISHOF and on a CD for whoever needs them. We are creating lists of photographers and developing a strategy for getting permission to use as many as possible. As rapidly as we get permission from photographers, photos which are presently restricted will be placed among those online and available for use. Our goal is to move 1000 photos from the restricted category to being available for use. At that point, we expect to have somewhere near 2000 photos available for use for celebrating swimmers prominent in USMS.

REPORT:

The Insurance Committee was deeply saddened to learn of the passing of one of their committee members, Betsy Owens. Betsy was a very active member of the committee. No matter the struggles she faced, she always found time to provide valuable input and make suggestions. She will be missed by all.

The insurance industry continues to change. More insurance carriers have been downgraded by the financial rating bureaus, which makes it especially difficult to chose our insurers wisely. It will again be a challenge to secure renewal coverages with reasonable premiums and appropriate terms and conditions.

The Insurance Committee will be working on educating our members by compiling a "grid" which will provide guidance on signing contracts with facilities and vendors. We hope to have this completed by Convention.

The International Committee continued to focus its energies on preparing a bid to host the 2006 Masters World Championships.

2006 WORLD CHAMPIONSHIPS

If held in the United States, the 2006 FINA World Championships would likely be the largest swim meet of any kind ever held. Judging from conversations with FINA officials, FINA is likely to look favorably on a bid to hold the meet in the USA in 2006. The last time the meet was held in North America was in 1994, in Montreal. Since then, championships have been held in Europe twice (Britain in 1996, Germany in 2000), Africa (Morocco in 1998), and Oceania (New Zealand in 2002). The 2004 meet is scheduled to be held in Europe (Italy).

The facility requirements for a meet that should attract a *minimum* of between 6,000 and 7,000 athletes eliminate all but a handful of pool complexes in the US. In addition to the swimmers and divers, we estimate 65 to 70 men's water polo teams (it is not yet clear if water polo will stage a women's tournament).

We will need two world-class 50-meter pools, a warm-up/warm-down pool, plus facilities for open water, diving, synchronized swimming and water polo. The meet will last an estimated 14 days, including two training days, so these facilities must be available for our exclusive use for those two weeks plus an additional day afterward for cleanup.

Recently I held extensive conversations with USA Swimming officials about potential facilities. We could identify only five facilities that could meet our requirements:

- Stanford University
- Irvine Novaquatics
- IUPUI
- Plantation, Florida
- Mesa, Arizona

In addition, it is possible that the new ISHOF complex in Pompano Beach, perhaps in conjunction with the Ft. Lauderdale complex, might be a sixth possible site.

There are problems or potential problems with several of the facilities:

IRVINE: The Irvine complex is undergoing renovations and will be ready in 2004, but City officials do not want to bid for any events until renovations are completed. Coach David Salo would like to host the meet and is willing to lobby on our behalf to present a bid this year (bids must be submitted to FINA by 31 December 2003).

MESA: Scheduled for completion in 2005, this indoor megacomplex has not even been started. In addition, there may be no local group with experience running a meet of this magnitude, though the Tempe Masters groups (Rio Salado and Sun Devil Masters) will have run two 2,000-swimmer Nationals).

IUPUI: There appears to be no interest in hosting this meet. In addition, the 1992 meet was held in Indy and it is doubtful that Indianapolis would be a major draw for foreign swimmers/tourists.

PLANTATION and ISHOF: These are outdoor facilities in a region in which heavy rains are common. Indoors would be preferable.

For a variety of reasons, we believe the Stanford and Irvine complexes would be our best bets.

The International Committee held a meeting on April 4. At the meeting, Myriam Pero, the Vice Chair, forwarded a copy of the contract we have received from FINA to all involved.

Key points:

- USAS will be the bidding organization and USMS will be the lead in this bid process;
- Each sport (Masters Swimming, Water Polo, Diving and Synchronized Swimming) would be the organizing committee and provide insurance coverage for its sport;
- USMS will bring the bid to USAS and USAS will submit it to FINA. Bids will_be reviewed and awarded at a FINA Bureau meeting in March or April of 2004;
- Jim Miller will be meeting with USAS in Chicago on May 24th and will present our progress;
- At this time, we do not know of any other countries considering bidding for this meet.

The preliminary budget, required by FINA, will exceed \$100,000 and include:

- A \$25,000 deposit (to be received with the bid and will be refunded only if we do not win the bid)
- 15 days of Hotel, per diem and local transportation for 4 FINA executives
- Travel, 17 days of hotel, per diem and local transportation for the FINA Bureau Liaison
- Travel, 17 days of hotel, per diem and local transportation for the 12 members of the FINA Masters Committee
- Travel and 2 days of hotel and per diem for 3 members of the Masters Committee who will travel to the site for the Inspection

Jim Miller sees the XIth FINA World Masters Championships 2006 – as a "Masters Aquatic Festival," with the event more of a festival than simply a meet. Ideally, it would contain a central kind of community of athletes, similar to an Olympic village, and offer nontraditional, "non competitive" programs and presentations

A first-draft, proposed schedule for the Championship, to be held in late July or early August looks like this:

- Day 10 Synchronized Swimming and Water Polo Competition (on site), Open Water Competition (off site)
- Day 11 Water Polo Competition (on site)
- Day 12- Water Polo Competition (on site), Open Water Training (off site)
- o Day 13 -
- Day 14 Closing ceremonies

Preparing the Bid

The International and Championship Committees will work together to prepare the bid. They will start with the Championship Committee's National Meet bid packet and modify as necessary - this would include the specifics of what they have to offer, what will be required of them and what they want, including financials

This packet will be send out to those facilities that are found to have the minimum requirements for hosting the meet, along with a deadline for submittal.

The International Committee has scheduled its next meeting for Wednesday, May 7th at 8pm, EDT.

REPORT:

Our principal goal in taking over from Sally Dillon in December 2001 was to streamline the championship process, primarily through a total conversion to electronic communications. With this in mind, we sent out last year's bid forms and championship packets via email. While this major change seemed to be accepted by the bidders and event directors, there remained a few problems with which we are dealing this year. First, we sent out essentially the same forms as before with only minor revisions. For example, in the bid package, we did not insist on electronic submissions nor did we limit the length of presentations at convention. This led to the main complaint we received on the convention feedback forms, namely that the presentations were too long. Second, the number of files in the championship packet (13 for OW, 11 for Postal) was excessive.

To meet these problems, we have: 1) Significantly revised almost all the forms and guidelines. For example, the evaluation form for the LD championships is now based on subtracting 0, 1, or 2 points for each evaluation criteria from a starting score of 100, making the evaluation less subjective than the previously used 5-point scale. 2) Put all the forms into a single Excel file and all the guidelines into a single Word file. These two files plus the contract and timeline make up the entire championship package. So instead of receiving an email with up to 13 attachments, the championship event directors need deal with only 4 files.

The entire LD Committee reviewed these changes. In addition to the usual assistance from Vice Chairs Marcia Cleveland and Randy Nutt, Rob Copeland was particularly helpful in polishing the championship forms.

On other matters, all events for 2002 have been finalized including All-Americans (David Vandam), All-Stars (Marcia Benjamin and Julie Stewart), Records (Jill Wright) and Awards (Robert Zeitner). The 2003 One Hour Swim has been successfully completed under the leadership of Kristine Lewis, and the entry forms for most of the other 2003 championships have been posted on the web.

Finally, many thanks to Lynn Hazlewood, our noble webmaster and liaison.

REPORT:

2003 is an on year for Legislative amendments, and while there has not yet been a lot of proposed amendments submitted, the Committee anticipates a more active summer and some lively convention debate over a couple of significant proposals.

Since the 2002 Dallas Convention, the largest project currently underway is the total rewrite of USMS Code - Part 4 "Athletes' Rights, Hearings, and Appeals". The Part 4 sub-committee, led by Laura Kessler, has made tremendous progress in simplifying and clarifying how USMS protects our members and how differences between members are resolved. The new Part 4 will most likely be the largest proposed amendment this year.

A second project that has received attention so far this year is our LMSC bylaws review. The Legislation Committee along with the Planning Committee and Legal Counselors Committee are looking into how best to assist LMSC's in insuring they have complete and viable bylaws. A model LMSC bylaws, based on a USA-Swimming model, is being discussed as a potential solution.

The Legislation Committee Governance task force has made modest progress since the convention. The task force is looking into how USMS is structured to recommend changes to our corporate organization, so we are better positioned to provide support and services to our volunteers, staff, and members. Some minor proposed amendments are anticipated this year, with more significant changes anticipated over the next few years.

As we move into the summer and approach the July 10th submission deadline, we anticipate additional proposed amendments will be submitted. The committee expects to see amendments dealing with On-Line Registration, how and when we elect the Zone Chair, the definition of various national committees, and the never ending code clarifications and housekeeping. Between the July 10th deadline and the 2003 convention the committee will review æch proposed amendment and, when needed, provide suggested improvements.

And finally, the Committee has been asked to participate in developing a Meet Management guide. We have been asked to prepare guidelines on the administrative aspects of applying for sanctions and understanding the meet director's obligations to the LMSC.

In closing I would like to express my gratitude to the members of the Legislation Committee for volunteering their time and efforts to make Masters Swimming a truly great organization.

REPORT:

The Marketing Committee has focused its attention to date on two areas, the on-going public relations efforts and the redesign of the USMS brochure.

The public relations focus is into its second year and we believe that we are benefiting from this outreach. To maximize resources and be as time-effective as possible in reaching the mass-market consumer audience that USMS has established as a key priority, we have developed fitness-oriented tips and packaged these as media tip sheets positioning USMS as a swim fitness expert. We have begun to utilize an affordable media distribution service to distribute these advisories and news releases on a targeted mass basis so that we can spend more time individually targeting the specific media outlets with true interest in Masters swimming.

Results of this strategy have been extremely impressive to date. Writers from media outlets including Runner's World, the Gwinnett Daily Post, Health Magazine, Essence Magazine, Heart & Soul, NikeGoddess.com, Ms. Fitness, and the Baltimore Sun have interviewed USMS sources. Articles mentioning or featuring USMS have appeared in mass-market media throughout the country, including Business Week, the St. Augustine Record, Aging with Style, Texas Jewish Post, Baltimore Sun, Senior/Boomer Times, West Texas County Courier, active.com, Jamestown (NY) Post-Journal, Indianapolis Star, Palm Beach Sun, and Florida Elder Update.

We also have resolved the time-consuming issue of photo use, enabling us to utilize photos in our possession and continue communicating with the media to establish USMS as a key news source.

Doug Garcia created the new brochure with help from a number of sources and 10,000 copies have been printed and delivered to the National Office. The brochure is oriented to demystifying Masters and explaining the features and benefits of the program. Thank you Doug.

TASKS FOR THE MONTHS LEADING UP TO CONVENTION:

With the completion of the new brochure we are turning our attention to other collateral support activities. We will be producing a series of posters that can be downloaded and printed form the web site.

We also want to focus on the marketing function and effectiveness of the web site and will be establishing a subcommittee to spearhead this initiative.

There were a number (+/-25, not a lot but representative of a larger silent constituency) of calls or emails expressing disappointment in the absence of the Planner this year and the committee will be deciding whether to resurrect this program and if so, how.

In producing the brochure we found that we are lacking in the extent of our photo file and will be discussing ways to address this issue.

REPORT:

USMS Conversion to Leoware: At the 2002 USMS Convention, a new "permanent swimmer ID" was adopted. The use of a computer is required to assign and re-register swimmers with this permanent ID. It was decided that the 2003 registration year would be a transition year, during which the LMSCs not using computers would have the chance to get comfortable with the USMS registration software (affectionately known as "Leoware").

At the start of the 2003 registration year (in November, 2002), there were eleven LMSCs that were not using Leoware. I'm pleased to say that as of today (March, 2003), all but one of those LMSCs has successfully converted!

This means that 52 out of our 53 LMSCs are now using Leoware. This is a TREMENDOUS achievement, especially considering it was accomplished in such a short time. The LMSC registrars are to be congratulated for their cooperation and perseverance in learning the new system.

Leo Letendre, Tracy Grilli, and Esther Lyman were instrumental in helping these LMSCs get computerized. Leo spent many hours assisting individual registrars with various installation and printing problems. Thank you, Leo!

Online Registration Forms: In March, 2003, I discovered that we had eleven LMSCs that did not have an electronic version of their USMS registration form on the Internet. I sent an e-mail to those LMSCs, offering to post their forms on the USMS web site. Those that had designed their forms on a computer sent me an electronic copy. Those who only had hard copies of forms mailed one to me and I re-created their forms in Word. By April, all eleven of those LMSCs will have their registration forms posted on the USMS web site.

The rules committee met to discuss the acceptability of USMS and USA-Swimming pool length certification forms which were completed prior to this year but which did not include a measurement of each lane. The committee determined that USMS should accept these forms at this time and that the issue will be brought before the House of Delegates in the fall for their determination. A sub-committee is preparing recommendations for possible inclusions in the Pool Length certification form. A number of questions and requests for interpretations have been received. Many of them have been concerning the pool length requirements. Unfortunately several meets have had their results voided because the bulkhead was not placed correctly and the distance not checked prior to the start of the meet.

- 6. It appears that a breakdown in communication had Patty Powis listed as Safety Education Committee Chair on the USMS website until the beginning of February. The alias "safety@usms.org" was still going to Patty until February. I was also missing from Board of Directors email lists (and just because my husband gets things doesn't mean that I do).

REPORT:

Following convention, all zones have turned their funds into the National Office to be placed into accounts for those zones with funds. Zones with funds will have free access to their money. A large part of the first half of the year has been occupied replacing Zone Representatives who have resigned. Doug Garcia has replaced Dan Frost as Zone Rep for Northwest Zone. Mike Lemke has replaced Melissa Rinker as Zone Rep for Great Lakes Zone. Barb Protzman has recently resigned as Colonies Zone Rep. Her replacement is in the process of being determined by the Colonies LMSC Chairs and will be announced within the month.

The committee is discussing a proposal to realign the Zone Chair election with the other four officers. After our deliberations, we will be consulting with the Legislation Committee on legislation proposals and election guidelines amendments that may be necessary.

BREADBASKET ZONE, continued

Colorado sponsored a swimmer's clinic this winter. Last year, the 'coach of the year' was given a stipend to attend the ASCA/MACA convention in Las Vegas. In return, she was to put together a clinic for local swimmers. Ellen Campbell, the coach of the year in 2002, selected two other local Master's coaches, Matt Beck and Nicole Vanderpole to assist with the clinic. It was considered highly successful, and plans are to do this again this year.

The Breadbasket Zone Championships are being sponsored this year by the Minnesota LMSC. They will be held on April 12 and 13, 2003, in Minnesota, in conjunction with the Minnesota State Short Course Championships. Minnesota is sponsoring a Masters Intensive Stoke Clinic on April 26 and 27 at Macalester College in St. Paul, Minnesota.

Ozark LMSC held their first 1650 meet on February 2, 2003. The Short Course Championships were held on March 29 and 30th at Washington University.

Missouri Valley Chairman Daniel Fisher has resigned as Chairman. Anna Lea Roof is serving as acting chairman until a replacement is found. Two winter meets held in this LMSC were the Lawrence Winter Meet on January 19th at the Lawrence Indoor Aquatic Center and the KC Blazers sponsored an all relay meet on February 16th.

DIXIE ZONE June Krauser, Zone Rep

Since the convention I have mailed out two newsletters. The October – December issue contained a synopsis of the written committee reports at the USMS convention. The January – March issue was mailed in January. The April – June issue will have the entry blank for the Dixie Zone Long Course Championships to be held in Geenville, SC. This championship was not on the calendar arranged at the convention but Roy Dessloch volunteered to host this championship.

There was a difference of opinion concerning the sanctioning of meets and who could participate in the meet. After a few e-mails, Rob Copeland responded with: "It is NOT a violation of a member's right, for a host organization to limit entrance into a sanctioned event, because of club membership."

Also since convention, USMS has decided that Zone's cannot have bank accounts. All monies have been sent to the USMS to hold for our use. After we have used up our money, then USMS will fund the Zone.

The 2002 Florida Gold Coast Local Masters Swimming Committee held its Annual Awards Banquet on January 3, 2003 with approximately 100 attending. This year's awards were beautifully embroidered towels. The 2002 Florida Local Masters Swimming Committee held its Annual Recognition Dinner on Saturday, February 9, 2003. Both were very nice affairs.

We look forward to our upcoming Dixie Zone SCY Championships in Savannah, GA on April 26-27 and our Dixie Zone LCM Championships in Greenville, SC on June 28-29.

GREAT LAKES ZONE Mike Lemke, Zone Rep

I was appointed to this position in January and am still in the process of introducing myself to the Great Lakes Zone and the other Zone Reps. I have made initial contact with all the LMSC Chairs in our Zone and I expect to get input from them to determine what the Great Lakes Zone needs to be doing.

There are two National Long Distance Championships being hosted by Great Lakes Zone teams - 1-MILE OPEN WATER CHAMPIONSHIP on June 28 and the 5K/10K POSTAL CHAMPIONSHIP.

I hope to involve the LMSC Chairs in the process of evaluating our goals for the rest of the year leading up to the convention and to determine if there are any issues facing the LMSC's or our clubs that have not be addressed.

NORTHWEST ZONE Doug Garcia, Zone Rep

Seems that all of the LMSCs within the NW zone are doing well. Alaska, Pacific Northwest Association, Oregon Masters and Inland NW Masters all have SCY champs either scheduled or completed. Our Zone SCY Champs will be held on April 26 and 27 in beautiful Hood River Oregon.

We decided via email vote the procedures that will be used for the distance Freestyle events in Hood River should the meet run long.

We also decided via email vote that the Zone LCM Champs will be at the King County Aquatic Center in Federal Way, Washington.

PROJECTS THAT HAVE TAKEN PLACE SINCE CONVENTION:

We have discussed the concept of a Zone Open Water Championship. We are taking a close look at our zone policies to help with site selection criteria for our zone championships. We are also starting the process of deciding which small LMSC delegates will receive funding to attend convention.

Hawaii LMSC has just sent me a notice of the death of Mike Sheldt, a freshman at UH and member of UH swimming. All are deeply saddened by his passing.

On a lighter note, Hawaii has the following upcoming sanctioned events: 3/22/03, Kailua Masters SC Invitational Swim Meet on Oahu. 5/4/03, Kaanapali Klassic 1.2 mile ocean swim in Maui, and June 27-28, 2003 the Hawaii SCM **OCEANA ZONE, continued**

International Masters Swim, also in Maui, followed by the 1500 M ocean swim on June 29th. Lastly, Janet reports that their webmaster has resigned recently to pursue her PhD at the Univ. of Colorado at Boulder. Congratulations to Mette Moffett. Hawaii also reports they have 556 registered swimmers.

Pacific registrar reports 5,521 registered swimmers and 107 clubs as of March 2003.

Mentor Coach Program – Part of the Pacific Masters Swimming vision is to continually strengthen the programs it serves through communication, education, and shared information. The Mentor Coach Program will sponsor a total of six 1-day opportunities for teams to send their coach to "shadow" a mentoring coach and gain experience and fresh perspective during scheduled workouts. Time will be set aside (2-3 hours) for discussions on topics of concern to a visiting coach and his/her team. A \$100 stipend will be provided to a team interested in sending a coach so that a "substitute coach" can be hired to cover duties. A \$100 stipend will be given to the mentor coach as an honorarium. This year's participating coaches are Rick Powers, Head Coach of Davis Aquatic Masters; Kerry O'Brien, Head Coach Walnut Creek Masters; Thomas Huggins, Head Coach of the San Mateo Master Marlins; and Brian Stack, Head Coach of the Manatee Aquatic Masters.

Napa Clinic – The annual Pacific Coaches Clinic featured a Masters Coaches Track on Saturday January 4, 2003. Pacific Masters Coaches Co-Chair Brian Stack organized the speakers for the clinic. They were Jim Montgomery, who spoke on the business of running the Dallas Area Masters Team and also spoke to the assembled clinic on a similar topic with a focus on how Masters Teams can enhance the success and profitability of the overall program. Rick Powers, from Davis Aquatic Masters spoke on his experience as the new head coach for the largest single team in USMS. Mike Collins tackled the problems of motivating swimmers with challenges and humor. Brian Stack led a Pacific Masters Coaches discussion of how Pacific Masters could be of more assistance to its local teams and coaches. More than 40 Masters Coaches registered for the clinic, and 26 Pacific Masters Coaches were awarded scholarships for the Clinic. This program is in its fifth year.

SOUTH CENTRAL ZONE Marcia Marcantonio, Zone Rep

South Central Zone has 6 LMSCs that are all running smoothly. Each has it's share of fitness and competitive events. The South Texas LMSC has found that it is sanctioning more open water events than pool events. The membership is very supportive of open water competition. One event is a national event, The 2 Mile Cable Swim. Several of the open water events are offering additional non-competitive novice distances to encourage first time open water swimmers.

One discussion has come up with the question, "Can LMSC officers or event directors/personnel be held liable for accidents which may occur at an open water event?"

Another discussion is about pool measurement. Some LMSCs say the LMSC should pay to have it's pools measured. Some raise the concern that LMSC money being spent on measurement only serves the competitive swimmers, which are a minority of the membership.

A project I will work on is making sure that all sanction chairs keep copies of pool measurement certificates. I will also have a zone file with copies of all certificates.

SOUTHWEST ZONE Wayne McCauley, Zone Rep

Membership

Southwest Zone has a very good year for membership and swim meets. Arizona LMSC will be putting on a great short course nationals in Tempe this year. This has led to an increase in membership in all our LMSC's.

SPMA swim meet attendance is the best in ten years. Las Vegas and several new teams have been very active in hosting additional swim meets. SPMA and Nova Masters hosted a USMS Mentors Clinic for coaches and swimmers in March.

San Diego—Imperial LMSC has more swim meets than before, with an excellent new facility to host swim meets. Arizona also hosted a mentor's coach and swimmer clinic at the Phoenix Swim Club in January, 2003. They are hosting some great swim meets in preparation for nationals this year.

Pool Meets

DISCUSSIONS AND PROJECTS THAT HAVE TAKEN PLACE SINCE THE LAST CONVENTION:

The committee has served as a sounding board for some organization-wide legal issues at the request of Legal Counsel. Committee members gave comments on whether there are potential problems with the use of photos on the USMS website and whether photos should be given to others for distribution. With the committee's advice, USMS is – through the efforts of the History & Archives Committee and its Chair – being diligent about maintaining photographer credits for photos in our archives and limiting the distribution of the photos. Some committee members have suggested asking or at least warning members on their registration forms that photos of them may be used by the organization.

Ad Hoc Legal Counselors Committee members also gave their opinions about signing waivers on-line, an issue that the committee has been considering for several years. The ability to sign valid waivers on-line is a prerequisite to moving forward with on-line registration for events and membership. Finally, enough time has passed since the passage of federal and state laws on the validity of electronic signatures to allow us to feel more comfortable advising USMS that it can go brward with this aspect of on-line registration. Since passage of the laws declaring the validity of agreements signed on-line, several other sport organizations have moved to on-line registration. USA Triathlon, for example, has been using on-line registration for almost two years and its registration processing vendors tell us that there have not been any challenges to the waivers signed on-line.

The Executive and Finance Committees continue to receive their monthly reports on the organization's financial condition including a narrative describing variances from the budget and prior year.

We will again be having an audit but that won't happen until the summer. Scheduling it later in the year helps control the costs but still makes the final report available for the convention.

I will continue to work with the Finance Committee and Internal Auditor to maintain our healthy financial position and improve our internal controls and processes.

FINA REPRESENTATIVE June Krauser

There has been no meeting of the FINA Masters Committee since a year ago in New Zealand. The Riccione Organization Committee had information to send to all the Federations but by e-mail the majority of the committee members had too many questions that have to be settled before the information will be available. The Riccione OC has sent out information on accommodations.

The FINA Masters Commission had a meeting in Lausanne SUI, on October 5-6, 2002. Many recommendations have been proposed. The commission is composed of the Chairman, the Secretary and the Bureau Liaison. Also attending were the Vice-chairman and Walt Reid.

Our FINA Masters Committee will meet in Riccione on May 30 & 31 and June 1, 2003. The agenda for the meeting is quite long. It consists of reviews, preparation of the Xth FINA World Masters Championships, review of the rules, approval of the updates for the Guide, future development of Masters swimming worldwide, official list no. 6, report of Masters World Records and Top Ten and the future direction for the new FINA Aquatic World magazine. Masters are allocated one or two pages every month in the new magazine. It can be obtained for a cost of \$69 USD a year. So far, I have only received the first issue – January

INTERNAL AUDITOR Jeanne Ensign

Last fall I drafted an internal audit plan for the year, with quarterly proposed activities and reports. As the year has progressed it is apparent my goals are very ambitious and that my time resources are not as plentiful as anticipated. It is a two year plan at the very least. In December I spent two days with our National Office Administrator reviewing and

documenting processes for collection and recognition of revenue, payroll administration, and payment of budgeted expenses that are initiated by there. Reviewing the registration collection process included a delightful, long lunch with Esther and Tracy.

My objective in the internal audit context encompasses operational and compliance risks, a little different than the traditional assessment of financial reporting risks. During the coming months, I hope to review and document processes for payment of budgeted expenses, contracted expenses, over budget expenses, and compliance with current contracts, including the payment process. To date the focus has been on activities at the USMS level, which is an ongoing process. In addition, I hope to initiate a review of the processes for collection and disbursements in one or more of the large LMSCs.

Findings and recommendations will be reported to the Finance and Executive Committees.

The NSG officers often rely on our expertise as they seek to improve the management of their Games.

The draft of a manual to assist State Games swimming coordinators is near completion. Chapters include general information, facility and equipment, personnel needs, data processing and additional suggestions. A timeline for meet directors is included, along with the NSG swimming rules. Best wishes to all USMS members who will be competing in Hampton Roads!

SWIM MAGAZINE EDITOR Bill Volckening

The last six months have been very productive. Since the last convention, we have continued to serve our members by planning, generating and editing contents for the National Publication, SWIM Magazine. We have facilitated increased communication between USMS and Sports Publications (publishers of SWIM Magazine), and between the many administrative leaders within USMS. SWIM Magazine continues to function as the primary print-media communication between the national organization and our members.

This year, in addition to all of the regular tasks associated with this position, I have been in the process of updating my home office, and upgrading from PC to Macintosh equipment. Since Sports Publications uses Macintosh equipment, this change will ultimately foster better electronic communication between my office and Sports Publications. In the past, exchanging files via e-mail has sometimes been challenging especially when files must be fully formatted before they go to SWIM.

An example of this type of file is the Quark XPress files of the USMS National Championship Entry Form. This four-page form is produced by USMS and sent in its final form to the publishers, who simply drop it in to the publication rather than retyping and reformatting it.

As some may recall, the computer equipment item was removed from my budget at the last convention. I removed this item to assist the Finance Committee with its budget problems. However, I still felt it was important to upgrade this equipment, which I have done.

As mentioned in previous reports, our shared goal is to educate, entertain, inform and uplift our readers. The complete list of discussions and projects that have taken place since last convention are too numerous to list, but it includes daily contact with USMS members, committee chairs, LMSC officers and administrative leaders. Currently, I oversee the production of at least half of the material for each issue of SWIM Magazine.

SWIM MAGAZINE EDITOR, continued

Leading up to the next convention, we have three more issues of SWIM Magazine to produce, including the July/August, September/October, and November/December issues. There will undoubtedly be numerous discussions regarding the content of these issues.

Of special interest this year is the discussion about the Championship Committees plans for future restructuring of the entry materials for the USMS National Championships. Discussions have been initiated and proposals have been presented. We expect more discussion with the Championship Committee about how we will present pre-meet information in the magazine in the future.

US OLYMPIC COMMITTEE LIAISON Hill Carrow

Another excellent Masters camp this year at the US Olympic Training Center. As has become the norm, the USOC has had yet another leadership change, with a new Acting CEO Jim Scherr. I know Jim well and have begun a dialogue with the new leadership. Also, the USOC is in the midst of perhaps its most drastic organizational changes ever. On the table is a proposal to reduce their Board of Directors from over 100 to only 9. This has been recommended by a USOC Internal Task Force. Congress has its own task force working on organizational changes. But if all stays on course, these changes will be approved no later than October.

USMS LIAISON TO INTERNATIONAL GAY AND LESBIAN AQUATICS (IGLA) Cris Meier-Windes

Highlighting a variety of events for IGLA in 2002 were the aquatic sports Masters competitions at Gay Games VI, November 2-8, in Sydney, Australia. The Masters Swimming events were an overwhelming success. Over 1,400 swimmers participated from around the world, some 500 of whom were registered with USMS. The meet ran smoothly with no major problems reported.

Jim Ballard of West Hollywood Aquatics set a world record in the men's 45-49 100m backstroke in 1:03.56. Five swimmers from Australia, Canada and the United Kingdom set 14 individual national records, in addition three San Francisco Tsunami men's freestyle relays earned consideration for USMS National records. **Tasks for the Months Leading Up To Convention**

The main event in 2003 is the upcoming IGLA Championships, to be hosted by the San Francisco Tsunamis Masters Swim Club. The meet will include swimming, (sanction #38-03-13 by PMS for USMS) diving, synchronized swimming (sanctions pending), and water polo (sanction #CK04507455 by USWP). It will take place August 21-24, at the Avery Aquatics Center on the Stanford Campus in Palo Alto, California.

USMS LIAISON TO USA SWIMMING Ted Haartz

Since the annual meeting in Dallas, TX in September 2002 at which Ron Van Pool was elected to succeed Dale Neuburger as President of USA Swimming, The USA Swimming Board of Directors has met twice in Colorado Springs, CO on October 25-27, 2002 and on January 24-26, 2003. Two (2) telephone meetings of the board were also called to vote on amendments to Swimming rule 103.2 Water Depths to include up to a minimum depth of four (4) feet that all starts must be from the deck or in the water. Old rule was 3 feet 6 inches minimum depth. (USMS rule 107.2.3 is still 3 feet, 6 inches.)

The other telephone meeting was an appeal to a National Board of Review verdict which will be heard by the Board on May 2, 2003 at the next regularly scheduled Board of Directors meeting in Colorado Springs.

While a fractious executive committee and board of directors at the USOC has made the organization the subject of much scorn with the appearance of dysfunctionality generating in-house and Congressional hearings and committees to make recommendations to restructure the USOC, the individual NGBs have continued their day to day operations of developing, training and funding their athletes for the upcoming Pan Am Games, World Games and 2004 Olympics despite the turmoil at the USOC.

A look at the performances of the USA swimmers at the recent NCAAs (in many sports), the USA Nationals and the just completed Mutual of Omaha Duel in the Pool between the Australian and USA National teams would seem to confirm that while the USOC was and is a current public relations disaster, the NGBs have not missed a beat in preparing for coming world events.

The USA Governance Committee continues its work with new legislation for the USA Swimming Code to be a subject of the 2003 convention in San Diego.

USMS LIAISON TO YMCA Stu Marvin

This year's YMCA Masters National Swimming Meet is scheduled for the Selby Aquatic Center in Sarasota, FL, April 24-27, 2003. This marks the second time in three years that the Sarasota YMCA has hosted this event. There are 451 athletes entered from 79 teams, with the largest hailing from Anne Arundel, MD. The team from Palisades/Malibu is again making the long trek from California, along with one lone representative from a team in Toronto, Canada. The YMCA Competitive Swimming & Diving Advisory Committee announced the dates and location of the 2004 YMCA National Masters Meet at their meeting in Fort Lauderdale. The dates are April 15-18, 2004 at the Fort Lauderdale Aquatic Complex along beautiful Fort Lauderdale Beach. The City of Fort Lauderdale is set to provide all participants with another quality run event.

USMS NATIONAL SPONSOR LIAISON Mel Goldstein

The first part of the year has been very busy, but yet very rewarding. Five of our USMS National Sponsors and three of our USMS logo licensee's agreements expired on December 31, 2002. All of the USMS National Sponsors whose agreements expired renewed for two more years (*TYR*, *Adolph Kiefer*, *The Victor*, *Arena*, *and Ultra Swim*). Two of the logo licensees have renewed (*Circle City Swimwear and Adolph Keifer*).

The use of the USMS Tradeshow display continues to be a valuable asset. The display to date has been to California, Texas LMSC's for marathons and health fairs. I attended the National Parks and Recreation Associations National Aquatic Conference in Albuquerque, New Mexico and the response was very favorable. I am scheduled to attend the Senior Olympic Games in Hampton Roads, Virginia and the ASCA World Coaches Clinic in San Diego, California. The display is also scheduled for Colorado and Ohio.

I have been working with Jim Matysek on featuring our sponsors on our website so that members can purchase items of value from our sponsors and become more aware of who our sponsors are.

During the past 6 months I have been working with several new sponsors and hope to make an announcement soon on a new USMS National Sponsor.

In addition to my other responsibilities I have been working with the Meet Directors for the USMS SC and LC Championships setting up their vendors areas so as to provide for the greatest exposure for our sponsors.

USMS WEBMASTER/IT DIRECTOR Jim Matysek

The Webmaster position is now a full-time position, allowing for timely updates to the regular sections of our web site and development of new features. In addition to supporting regular features like the Discussion Forums and releasing new press releases from our PR consultant, the 2003 rule book and LMSC handbook have been published, the 2002 convention results were published, updates have been made to our coaching programs, and the short course nationals information and on line entries were released. We had a record high of 1,312 on line entries for this meet.

In addition the usual web site updates, I have been working on database task force this year. One of the major activities of the task force has been to issue the RFP for conversion of the History & Archives web site and data. For this activity, I

am a part of the RFP management team that reviewed the bids and selected the contractors for this RFP and will also work with these contractors to implement the RFP. In addition to the RFP, decisions regarding the nature of our database and the structure of the basic tables in the database have been made, as well as planning some future implementation tasks. Throughout the year, I've also implemented some new features in the database that are in keeping with the overall plan and structure. We now have available on our web site a history of all USMS Awards that have been presented over the years, a new dynamic structure for pool and long distance records, and a listing of known relay All Americans. We also have a direct link into the USMS registration database, which will be a key element for future development. All of these features were implemented using the USMS database.

In addition to the features that have been rolled out this year, as the IT Director I am also responsible for our server. We purchased a new, more powerful server late in the year and concluded our move of all services to the new server in early January. The server move occurred as well as can be expected, but we have encountered a problem with our new service provider. The IP addresses assigned to our server are all part of a blacklisted block of addresses. This entire block of addresses is blacklisted due to a known spammer operating within this range (having nothing to do with us or our provider). The result is that a number of mail addresses will not accept email from our server due to spam blocks. I've been working with our provider to try to find a solution to this problem since the move, and it may result in another move of our server to a new provider.

As part of operating our own server, we still offer free web hosting to our zones, LMSC's, and registered clubs. As of this writing, we are hosting 35 live web sites. There is still plenty of space and server processing power available for others to take advantage of this service.

TASKS FOR THE MONTHS LEADING UP TO CONVENTION:

- Complete the conversion of the History & Archives web site to a dynamic database-driven site per the RFP that was issued this year.
- Create on line entry system for long course nationals and process entries. Process and post results from both short course and long course nationals.
- Convert the current Calendar of Events to an on line database and add the capability for LMSC Sanctions Chairs

USMS LIAISON TO USA TRIATHLON Cindy Hawkinson

What a challenge, establishing a relationship with USA Triathlon. A natural blend yet such different ways of thinking when it comes to swimming. USMS has primarily been a competitive swimming organization. Yet, we have always recognized that there are many, many fitness swimmers out in our community who love to swim just for the fun of swimming and getting into shape with others. Now, we have another type of athlete, with a different agenda and competitive season – triathletes. They are a different breed of swimmer. But, swimmers they are by default as the first leg of a triathlon. Their goals are much the same as all athletes. By Convention 2003, I would like to have established a good relationship with my new contact. I would also like to have tentative dates set up for 3 or 4 triathlons throughout the U.S. to have the USMS booth set up at the expos. This will get the USMS name out in the triathlon community. I need the cooperation of LMSCs in the West, East, and South. I can handle the one here in Colorado. I am going to target the Boulder Peak Triathlon in August, 2003. Olympic or Sprint distance triathlons are the target distance. At these booths, I would foresee masters swimmers answering questions, distributing registration forms, distributing the Karen Smyers SWIM magazine article and any thing their particular LMSC may offer.
