- Deck entries.** Bring the completed entry form or complete a form at the meet, show your USMS membership card (if you are a member), and pay your entry fee.
- Rules:** US Masters Swimming rules (<http://www.usms.org/rules/>) will apply. The meet host will have two watches/timers available for each lane; please notify the starter prior to any race if your lane does not have two timers. Swimmers who are attempting world, national, or Michigan Masters records should notify the starter immediately prior to the race to request a third timer.
- USMS Registration:** USMS recognized meets are open to participation by both USMS members and non-members. Persons interested in membership should go to <http://www.michiganmasters.com/> for registration information. Membership applications will not be available at the meet.

### **The John Munley Memorial Swimming Scholarship**

John Munley swam for Michigan State University from 1997-2001. Not heavily recruited out of high school, John went on to be the Most Valuable Swimmer for all four years, he served as Team Co-captain, and qualified for Olympic Trials. He finished his senior season with the varsity record in the 200-yard freestyle. John passed away while jogging on campus during the spring of his senior year.
