Masters Grand Prix Sunday March 17, 2013

Sanction: This meet is held under the sanction of USMS and NMMS. Sanction number XXX-XXXX.

Eligibility: Any swimmer with a valid 2013 USMS registration. One day USMS registrations are available.

Facility: West Mesa Aquatic Center, 6705 Fortuna Road NW, Albuquerque, NM 87121. The pool is 8 lanes by 50 meters (configured as 25 yards), equipped with non-turbulent lane lines and Colorado Timing System with an 8 lane scoreboard.

Start Time: Warm-up opens at 8:00 AM. Events start at 9:00 AM.

Events: All events are timed finals. Swimmers may enter a total of **5 individual events** plus relays. All events will be pre-seeded, men and women combined, slowest to fastest.

Scoring: For individual events, scoring is by gender and age-group: M & W 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75-79, 80+. 1st-8th place: 9, 7, 6, 5, 4, 3, 2, 1 points. For relay events, scoring is 1st-8th place: 18, 14, 12, 10, 8, 6, 4, 2 points.

Awards: Trophy awarded to the top team. That's the grand prix!

Entry Fees: Entry fee is \$25.00. All proceeds, after pool usage fees, to benefit Duke City Aquatics Age Group Swimming and Water Polo (equipment and travel). Additional donations are accepted!
