

## Common Ground Masters "Pre-Super Bowl Swim Meet" Sunday, January 26, 2014

Hosted by: Common Ground Masters and Nebraska Masters Swimming

**Location:** Common Ground Community Center, 1701 Veterans Drive, Omaha, NE 68022

**Date/time:** Sunday, January 26, 2014. Meet will run from 8:00 AM to approximately 1:00 PM

Meet schedule: Warm-up #1 – 8:00-8:45 AM, with 1650 & 1000 events starting at 9:00 AM

Warm-up #2 - 10:00-10:45 AM, with all other events starting at 11:00 AM

Sanction: Sanctioned by the Nebraska LMSC for USMS, Inc., sanction number 294-S001.

**Pool:** Eight-lane 25 yard pool with backstroke flags and non-turbulent lane markers, Colorado electronic timing system with touch pads and scoreboard, and spectator seating. Six lanes will be used for competition with two lanes available for warm-up/cool-down throughout the meet. The length of the competition course without a bulkhead is in compliance and on file with USMS in accordance with articles 105.1.7 and 107.2.1.

**Rules:** Current USMS rules apply. All participants must be registered members of U.S. Masters Swimming for 2014. All events are timed finals and will be pre-seeded slowest to fastest with men and women seeded together. Individual competition is in age groups of 18-24, 25-29, 30-34, 35-39, etc. Relay age groups are 18+, 25+, 35+, 45+, etc. The youngest member of the relay determines your age group. All four swimmers must be registered with the same club for relays. A swimmer may swim only one leg of a relay. Relays may be mixed genders. Your age as of January 26<sup>th</sup>, 2014 determines your age group eligibility.

**Event Limit:** Swimmers may enter a maximum of five (5) individual events. Swimmers may enter either the 1650 or 1000, but not both. The 1650 and 1000 are limited to the first eight swimmers who sign up in each event. Events may be combined based upon number of entries.

Entry Information and Fees: Meet entry fee is \$25.00. Meet is open to all 2014 USMS-registered swimmers. One-event memberships (USMS registration with insurance coverage for this meet only) will be available for \$15.00 in addition to the \$25.00 entry fee. Deck entries will be accepted on the day of the meet until 8:30 AM for the 1650/1000, and 10:30 AM for all other events, for a fee of \$35.00. Deck entries may be seeded in separate heats. All entries (except day of meet deck entries) must be received by Wednesday, January 22<sup>nd</sup>. Make checks payable to "City of Omaha." Entry fees are non-refundable. A copy of your 2014 USMS registration card must be included with your entry form. Entry cards for relays must be filled out at the meet and turned in to the meet director by 11:00 AM.
