Time: Saturday--Warm ups at 9:00 a.m. Meet begins at 9:30 a.m.

Location: The Marist pool is an 8 lane 25 yard pool, and is located off of Ashford Dunwoody Road. Directions from 285 would be: Go 285 to the Ashford Dunwoody exit. From Ashford-Dunwoody, go SOUTH approximately 1 mile. Turn RIGHT on Harts Mill Rd (stoplight), just past the Marist sign, which is on the right. Follow the road around and park in the big parking lot which is on the right toward the far end. The pool is on the opposite side-you will walk a little ways to get there, but it is straight ahead from the parking lot. Note that there is construction going on, so you should pass the construction on your left as you walk to the pool. Marist Athletics: 770/825-9032.

Alternate route: you can also get on Ashford Dunwoody from Peachtree Rd (just north of Oglethorpe). From this direction, you will turn LEFT to go into the Marist campus. If you have trouble, contact Tim Storsteen at 404/307-1464 or Terry Blish (Athletic Director) at 770/639-5153.

Eligibility: The meet is open to all persons 18 years and older as of **February 22, 2014**. USMS REGISTRATION IS REQUIRED. If you are not registered, your application can be accepted at the meet. Be sure to include a copy of your USMS card with your entry.

Events: Swimmers may enter up to five events.

Awards: Ribbons will be awarded for 1st, 2nd, and 3rd places.

Timing: Electronic timing will be used, with hand held watches as a backup. **Note:** This is a Category I Meet. Times will not count for Top Ten or Records.

Fees: \$20.00 for up to 5 events; \$2.00 surcharge for deck and late entries (received after **February 20**); \$1.00 surcharge for entries without 3 x 5 index cards. Make checks payable to GEORGIA MASTERS. Mail to:

Seeding: Entries received by **February 20** will be seeded. Women's heats will precede men's heats. Sexes may be combined for some heats. NTs will be placed in slower heats, except for the 500 free, which is fast to slow.
