

Burn off the Bird Endurance Challenge

Hosted by the Northern Nevada Aquatics November 25th, 2017

LOCATION: Northwest Pool, 2925 Apollo Way, Reno, NV 89503 - (775) 334-2203.

DIRECTIONS: From I-80 East, take Keystone Ave (Exit 12), left onto Keystone Ave, left

onto Kings Row, left onto Wyoming Ave, right onto Apollo Way, the pool will be on the right. From I-80 East, take Keystone Ave (Exit 12), right onto Keystone Ave, left onto Kings Row, left onto Wyoming Ave, right on Apollo Way, the pool will be on the right. Parking will be on the street

or in parking lots adjacent to the pool. Please be respectful when driving in the area and when parking on the street as this pool is a

neighborhood.

COURSE: Indoor, heated, 25 yd., 8-lane pool. The event will run all 8 lanes. All

timing of intervals will be on digital pace clocks mounted on walls.

FACILITY: Men's/Women's showers and locker rooms are available. There will

be bleacher seating for spectators. There is limited deck space.

TIME: The event warmups begin at 2:00pm. The endurance challenge begins

at 2:30pm. At the half way point, we will take a 10 minute break. The

event will be done by 5:30pm.

DESCRIPTION: We will be doing an endurance challenge formatted event. All athletes

will be split into lanes with athletes doing similar distances. Each athlete will do the full distance (50, 75, or 100 yards) every 100 seconds (1 min, 40 sec). Each athlete will do a full 100 repetitions of the distance on the 100 seconds. After 50 repetitions, there will be an extra 10 minute break.

Upon completion, all athletes will have finished the challenge.

To aid the athletes, each lane will have a lane director that will help with

intervals and the total repetition count.

The event will not be endorsed by the rules of USMS or USA Swimming. Neither rules will govern the event. This challenge is a stand alone

event.

This event is sponsored by the Hands For Life Organization.

ELIGIBILITY: All entrants are eligible with a clean bill of health.

AWARDS: All competitors will receive a distinctive award for participating.

ADMISSION: Admission to spectate is free.

CHECK IN: The event will be deck seeded. Check-in will open at 1:45 pm. Swimmers

must check in for their events by 2:30 pm.

ENTRIES: TWO OPTIONS FOR MEET ENTRY

Entries must be on attached entry form. Entries must be printed and filled

NOVEMBER 20TH or hand delivered by FRIDAY NOVEMBER 24TH to the event director. Entries post-marked after that date will be deck entered.

ENTRY FEE: \$25.00 per individual for registration on or before November 24th.

\$30.00 per individual for registration the day of the event. This fee

includes pool use and awards.
