- One lane will be open for continuous **warm-up/cool-down** during the meet (only feet-first entry permitted in this lane...no diving)
- **Lap counters** will be provided for **500 Free**. Max. 2 heats for #17/18
- **Warm-up/Meet Start Times:** 9:00am/10:00am. Follow Ref instructions
- Watch for Email entry confirmation. Programs available by 9:50am
- **Fee - \$20.00 per swimmer.** Events will be pre-seeded, timed finals
- **Postmark entries by Tuesday, April 3rd, 2018.** Deck Entries are permitted until 9:15am, but **entries after April 3rd = \$30 fee**
- You may **enter up to 5 events** (not including relays or 25 “sprints”)
- Final results will be emailed to all participants following the meet
