DESCRIPTION

- Facility: The Johnson Ranch Pool has two outdoor 25 yard pools (8-lane x 25 yard, 6-lane x 25 yard). The swim meet will take place in one pool with the other for warm-up/warm-down. The primary timing system will be automatic timing. Times may be submitted for USMS records and USMS Top 10 consideration. The length of the competition course is not on file with USMS. Eligibility of times achieved in this meet will be contingent upon pool length measurement and approval with USMS (USMS articles 105.1.7 and 107.2.1)
