RULES, POLICIES, AND RISK ASSUMPTION

Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP"), will govern this meet.

Any swimmer entered in the meet, must be certified by a USA Swimming-member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of January 16, 2021 shall determine the swimmer's age for the entire meet. Indiana Swimming does not process onsite memberships.

At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee may assist in making arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.

The competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Rule 205.10.1. All swimsuits shall be made of textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

Coaches and Officials MUST display their current USA Swimming coach credential or Deck Pass to gain deck access. The meet referee and/or meet director reserves the right to ask for coach credential or Deck Pass and/or deny deck access if coach does not comply or card is no longer valid/current.

The use of audio or visual recording devices, including a cell phone, is not permitted in any changing area, restrooms, or locker rooms. Deck changes are prohibited. It is understood and agreed that USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.

COVID Risk Assumption

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. Safe Sport 360

The Minor Athlete Abuse Prevention Policy prohibits Applicable Adults (as defined) from having one-on-one interactions with minor athletes which are not within an observable and interruptible distance from another adult. Applicable Adults are required to abide by this policy in full during this meet.

§ Pursuant to USA Swimming Rules and Regulations and federal law, it is every member's responsibility to immediately (i.e., within 24 hours) report any incident of child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport. COVID POLICY ADDENDUM (SAFETY PLAN)

VIGO COUNTY SCHOOL CORPORATION AQUATIC CENTER COMPETITION PLAN

Team and Meet Personnel

- 1. Only athletes, coaches, and meet officials that are registered USA Swimming members or members of a school team that are competing will be allowed on the pool deck.
- Athletes will have to wear a mask when they are not competing. This includes when using any common space including the locker room, bleachers, or on the pool deck for any reason. Athletes should wear their mask to the blocks, remove the mask to compete and then replace the mask when returning to the team area or warm down pool.
- 3. Other team personnel (coaches and trainers) and meet officials will also have to wear a mask at all times.
- 4. Divers during warm-ups, meets and practice will stand 6 feet apart while diving.
- 5. Teams will be assigned specific seating areas during the meet that will space athletes as best as possible.
- 6. Limit the number of people in the pool and on deck to 182.
- 7. Any athlete or meet staff experiencing any symptoms of a fever (100.4 or higher), recent cough, unusual fatigue, headache or have been exposed to any person who has had COVID-19 symptoms. This includes family and friends. This person should remain at home.
- 8. Swimmers that do not follow the rules will not be allowed to swim.

Spectators

- 1. Spectator seating will be limited to 68.
- 2. Spectators may enter through the main lobby (entry # 1) and exit the pool through the north door (entry #7)
- 3. Spectators are asked to move outside during club events at this time so all parents can watch their student swim. Outside announcing will be done to give everyone opportunity walk in to see the swimming competition.
- 4. All spectators will have to be masked at all times while in the aquatic center.
- 5. Any spectator experiencing any symptoms of a fever (100.4 or higher), recent cough, unusual fatigue, headache or have been exposed to any person who has had COVID-19 symptoms. This includes family and friends. This person should remain at home.

PA announcement before the meet, during meet, printed in the meet program and posted at the entrance:
