CONDITION OF SANCTION

MEET COVID 19 PLAN

NCS FACE COVERING STATEMENT

Following new CDC recommendations and the North Carolina Governor's latest Executive Order issued May 14, 2021, North Carolina Swimming has revised guidance on the use of face coverings at USA Swimming activities as follows:

- North Carolina Swimming strongly recommends that partially vaccinated or unvaccinated individuals continue to wear face coverings and practice social distancing at all swimming activities.
- The Triangle Aquatic center requires that all meet participants swimmers, coaches, officials and volunteers wear face coverings at all times while in the Facility.
 Swimmers on deck preparing to enter the water and immediately exiting the water and the on-duty lifeguards are the only noted exceptions to this policy.
- NCS members are expected to comply with all COVID-19 safety guidelines from USA Swimming, North Carolina Swimming, the State of North Carolina, local jurisdictions, aquatic facilities, and member clubs.

FACILITY and TAC TITANS REQUIREMENTS

TAC TITANS has discussed specific health and safety procedures with the venue management. At this time, the facility and TAC TITANS have no additional requirements. Compliance with the most current guidelines from USA Swimming, North Carolina Swimming, CDC, State and Local jurisdictions will be maintained throughout the duration of the meet.

SPECTATOR LIMITATIONS and PROTOCOLS

There will be no "In-Person" spectator viewing. The meet will be live streamed via TAC-TV. Spectators may not enter the facility except monitored use of the restrooms located in the lobby.

PARENTAL ACCESS

Parents needing access to their athlete during the meet in a closed-deck environment can contact their children directly via cellphone and arrange to meet them just outside the lobby. Should parents be unable to contact their child directly, they should see the attendant at the front desk in the lobby. In the case of an emergency, please call 919-459-4045

FACILITY

The Triangle Aquatic Center (TAC) provides 3 indoor pools. The 50-meter competition pool with bulkhead offers a total of 8 50- meter competition lanes with a depth of 7 to 12 feet that can be configured for separate 8-lane and 10-lane, 25-yard competition courses. The competition course has been certified in accordance with 104.2.2C (4). A copy of such certification is on file with USA Swimming, Inc. The competition lanes are a minimum of 7 feet wide. The 25-yard program pool allows for 4 to 10 warm-up/warm-down lanes at any time.

The separate warm water instruction pool is fully enclosed and remains open to the public during meet competitions. There is a Daktronics OmniSport 2000 Pro Swimming timing system with HD video scoreboard. Meet participant parking is available across from the swimmer drop-off loop and in the shopping mall lot adjacent to the pool. Illegally parked vehicles are liable to be ticketed or towed by the local Police Department and the owner's expense.

Per USA Swimming and Safe Sport Rules...ONLY registered athletes, current registered officials and coaches may be on deck during warm-ups and/or competition. ALL coaches, officials and meet personnel will be required to wear wristbands or lanyards on the pool deck. Please check-in at the clerk of course.

The length of the competition course is in compliance and on file with USMS in accordance with articles 105.1.7 and 106.2.1, but as a bulkhead course, is subject to length confirmation. Eligibility of times for USMS Top 10 and records will be contingent on verification of bulkhead placement.

MEET FORMAT

This is a timed final Age Group/Senior/Masters pre-seeded meet. unless otherwise indicated.

Meet management reserves the right to combine sessions, add sessions, or move an age group or gender to a different session depending on the number of entries in the meet to ensure the meet runs efficiently. Coaches will be notified by email of any changes to the sessions within 36 hours of the entry deadline.

The Meet Referee reserve the right to combine heats and/or events.

SAFETY

The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. NO running or horseplay will be tolerated.

Swimmers may be dropped off only in designated safe areas.

Swimmers are not permitted in work out rooms, storage rooms, meeting rooms, or control rooms.

Anyone failing to comply with a safety request may forfeit his or her privilege to participate.

We strongly recommend each team assign a marshal to monitor warm-up sessions in addition to host team marshal.

Only swimmers, properly certified officials and coaches, and meet volunteers will be allowed on deck. No spectators will be allowed on deck at any time. All persons on-deck or behind the blocks must be USAS certified coaches, officials, registered swimmers, or meet volunteers.

RACING STARTS

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

RULES

This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional and exceptions are stated.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.

Deck changes are prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas, and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present.

Neither photography nor video recording is permitted behind the blocks.

These rules apply to USAS and USMS.

MAAPP

All applicable adults participating in or associated with the meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Protection Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

ELIGIBILITY

Age Group: All amateur swimmers under the age of 19 are eligible to swim in the age group events. Swimmers may be registered swimmers may be registered members of USA Swimming, however, registration is not required. There will be no on deck registration available at this meet. Swimmers must compete in the age group corresponding to their age as of the first day of the meet. No swimmer will be permitted to swim in an older age group.

Masters: All master swimmers, 18 and older, are eligible to swim in the masters events and may be registered with USMS, however, registration is not required. There will be no on deck registration available at this meet. Masters age is determined by their age as of the last day of the meet.

TECHNICAL SUIT BAN FOR 12&U

Per USA Swimming rule 102.8.1.F, 12&U athletes may not compete in Technical Suits at this meet. A Technical Suit is one that has the following components: Any male or female suit with bonded or taped seams regardless of fabric or silhouette; or any male or female suit with woven fabric extending to the knee or mid-thigh regardless of the seam type.

SWIMMERS WITH DISABILITIES

The TAC Titans welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit Star Aquatics' ability to accommodate all requests.

ENTRIES

Email is preferred for submitting all entries including Hy-tek format entries and non-team entries. All entries are to be submitted to the meet entry coordinator listed above by emailing jriley@tactitans.org. No telephone, fax, or mailed entries will be accepted.

After entries are submitted, the following must also be received before teams/swimmers may participate in the meet.

1. All fees (team or individual) must be sent to TAC Titans (275 Convention Drive; Cary, NC 27511) OR notice that payment will be made on site must be

sent to Jennifer Riley at <u>iriley@tactitans.org</u>, Make checks payable to **BODYARMOR STATE GAMES OF NC.**

- 2. An athlete roster must be included with your payment. Roster Form can be found on page 14. The Roster Form may be scanned and emailed with your entries.
- 3. A Waiver by each swimmer/parent **MUST BE COMPLETED BEFORE COMPETITION**. A Team may list the swimmers' names and have parents sign on one page. Waiver must be mailed to TAC Titans (275 Convention Drive; Cary, NC 27511) before the meet OR scanned and emailed to jriley@tactitans.org or submitted at check in. Failure to do so will result in YOUR TEAM NOT BEING ABLE TO PARTICIPATE, BUT YOU WILL BE REQUIRED TO PAY FOR ENTRIES.

Entry requirements are the same for USAS and USMS.

ENTRY LIMITATIONS

Swimmers may swim a maximum of 4 individual events per day and a total of 8 individual events for the meet. Meet management reserves the right to limit the number of entries. If it becomes necessary to return entries that may have been received prior to or on the entry deadline, entries will be accepted as deemed proper by meet management, giving preference to those competing both days of the meet and whose entries are complete in every respect and those that agree to provide volunteer officials, timers, and other workers. Submit names of persons volunteering on the accompanying form. Meet management also reserves the right to limit the number of heats in the 500 Freestyle to control the length of the competition. Entry limitations are the same for USAS and USMS.

ENTRY VERIFICATION An email will be sent to the person submitting the entry confirming receipt of the entry within 48 hours of receipt. Time changes of warm ups, etc., will be announced by email to the person who sent the entries on Monday, June 14, by 3 pm.

ENTRY DEADLINES

The Meet Entry Coordinator must receive entries by the date and time listed in the Meet Schedule above. Late entries may be accepted at the discretion of the Meet Referee. There will be no on deck entries. Meet Management reserves the right to limit or suspend the addition of swimmers or heats to accommodate late entries. Entry deadlines are the same for USAS and USMS.

SEEDING

The conforming time standard for this meet is short course yards. Swimmers will be seeded and swim from slowest to fastest unless otherwise indicated. All non-conforming times will be seeded last in rank order. Seeding is the same for USAS and USMS.

SCORING

The meet will not be scored.

AWARDS

Gold (1st place), Silver (2nd place), and Bronze (3rd place) medals for each event for the following age groups: 8 & Under, 9 - 10, 11 - 12, 13 - 14, 15 - 16, 17 - 18, 19 - 29, 30 - 39, 40 - 49, etc.

The manner in which awards will be distributed will be determined by the meet host and participants will be notified prior to the meet.

RESULTS

Results will be posted on the BODYARMOR State Games of NC website at www.ncsports.org within 24 hours of the meets conclusion. Results can also be found on Meet Mobile and the TAC Titans website during the course of the meet. Teams may obtain Hy-tek backups via an email attachment at the conclusion of the meet sent by the Meet Entry Coordinator.

The length of the competition course is in compliance and on file with USMS in accordance with articles 105.1.7 and 106.2.1, but as a bulkhead course, is subject to length confirmation. Eligibility of times for USMS Top 10 and records will be contingent on verification of bulkhead placement.

COACHES

All coaches on deck must check in and wear credentials at all times. There will be a coach/general meeting at the date and time listed in the Deadline and Meeting Summary. Other meetings may be held at the meet referee's discretion. Meet Management requests that at least one coach representative from each team attend all coaches' meetings.

OFFICIALS/ TIMERS/ VOLUNTEERS

There will be a need for officials. TAC Titans welcomes and encourages anyone willing to volunteer to contact the Meet Referee by email prior to the meet or sign in once you arrive at the meet. All officials on deck must be registered and certified with USA Swimming and will be required to show proof of such to the meet referee by displaying their registration card or showing their Deck Pass virtual membership card upon request. A certification card showing the official's level of certification must also be presented. Any official's assistance will be greatly appreciated and will help to ensure a great meet for the swimmers. Official briefings will be held in the hospitality area at the date and time listed in the Meet Schedule table. All teams are asked to provide and list Officials for the meet. Please list on the Volunteer Sheet. TAC will provide timers, hospitality, computer operators, etc., to run the meet. Volunteers who work a minimum of 4 hours will

receive a free BODYARMOR State Games Volunteer t-shirt.

HOSPITALITY/ CONCESSIONS

There will be a hospitality area open to all coaches and officials. Lunch for all volunteers (timers, runners, officials, *etc.*) will be provided by the BODYARMOR State Games and TAC Titans.

WARM-UP

In accordance with USA Swimming guidelines, there will be a published warm- up procedure for all swimmers and coaches attending the meet. The Marshal will ensure all teams, coaches, and swimmers follow all warm-

up procedures. Meet Management reserves the right to change warm-up times according to the number of entries. During the competition, there will be lanes available for continuous warm-up/cool-down in the diving well. There is to be no diving or horseplay in this area. Only **feet-first entry** into the warm-up lanes is permitted.

WAIVER/ RELEASE

As a team or individual entered in this meet, upon entry you are acknowledging that you are familiar with the Safety Rules of USA Swimming, Inc., USMS Swimming, Inc. and North Carolina Swimming, Inc. regarding warm- up procedures and meet safety guidelines, and that you shall be responsible for the compliance of your swimmers with those rules during this meet. T A C T i t a n s , Triangle Aquatic Center, North Carolina Swimming, Inc., USMS Swimming, Inc., USA Swimming, Inc., their agents, employees, and coaches shall be held free and harmless from any and all liabilities or claims for damages arising by reason of illness or injury to anyone during the conduct of this meet. You acknowledge that by entering this meet, you are granting permission for the names of any or all of your team's swimmers to be published on the internet in the form of Psych Sheets, Meet Results, or any other documents associated with the running of this meet.

USMS swimmers must sign the liability release prior to participating (found at the end of this document).

IMAGE RELEASE

All participants agree to be filmed and photographed by the host club approved photographer(s) and videographers and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or NCS website or social media or in public broadcast of the event via television or webcast. ("USMS") allowing me, the undersigned, to participate in any USMS sanctioned or approved activity, including swimming camps, clinics, and exhibitions; learn-to-swim programs; swimming tryouts; fitness and training programs (including dryland training); swim practices and workouts (for both pool and open water); pool meets; open water competitions; local, regional, and national competitions and championships (both pool and open water); and related activities ("Event" or "Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement (the "Agreement");

- 1. I hereby certify and represent that (i) I am in good health and in proper physical condition to participate in the Events; and (ii) I have not been advised of any medical conditions that would impair my ability to safely participate in the Events.
