Location: Vigo Schools Aquatic Center – Voorhees Park

Aquatic Center:

Facility specifics: 10 lanes, 50-meter-long pool divided by 2 moveable bulkheads for 1 competition pool and 1 warm-up when the pool is configured in short course yards. Colorado Timing Systems electronic timing equipment and an LED matrix display board with video capabilities will be used.

The length of the competition course is in compliance and on file with USMS in accordance with articles 105.1.7 and 106.2.1, but as a bulkhead course, is subject to length confirmation. Eligibility of times for USMS Top 10 and Records will be contingent on verification of bulkhead placement. Times from this competition will be eligible for USMS records and Top 10 consideration, but not for world records.

Water Depth: The water depth measured for a distance of 3 feet 3 ½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from the turn end is 6 ft. and at the start end is 6 ft.

The competition course has not been certified in accordance with 104.2.2C(4). The water depth measured for a distance of 3 feet 3.5 inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from

the turn end is 6 feet and at the start end is 6 feet. Reference rule 102.2.3. A separate pool is available for warming up and warming down.

Facility Notes:

Free parking is available on the west side of the building. Please park in marked spots only and not in fire lanes or on the grass. All individuals should use the northwest entrance to gain access to the aquatic center. All other entrances will remain locked. On Friday, the outside doors to the aquatic center will open at 4:00 PM EST for swimmer drop-offs. Doors to the spectators seating will open at 5:00 PM EST. On Saturday and Sunday, the outside doors to the aquatic center will open at 6:30 AM EST for swimmer drop-offs. Doors to the spectators seating will open at 7:30 AM EST. If the start time for a session is delayed, facility doors will open later corresponding with the delay. Due to USA Swimming insurance requirements, only swimmers, credentialed coaches and officials, and meet workers will be allowed on deck. There are no exceptions! Deck access is located to the left of the concession stand. Access to spectator seating is located to the left of the lobby restroom. All swimmers, coaches, officials, and spectators are asked to treat the facility like it was their own.

- 1. Smoking in NOT PERMITTED on the aquatic center's property
- 2. Do not go or let your children go to unauthorized areas
- 3. Please discard all waste into the appropriate trash and/or recycle bins
- 4. Please keep track of your belongings. THT and the VCSC are not responsible for any lost or stolen items

Any person caught abusing the facility or attempting to gain access to unauthorized areas, will be asked to leave the meet. No refund of admission will be given.

Refreshments:

Concessions will be available throughout the meet. Credit/debit cards will be the only form of payment accepted. Concession stand will no longer accept cash. Hospitality will be provided for Coaches and Officials.

Broadcast/Image Authorization Policy:

Any photographs, videotape, or other audio and/or visual recordings of the event created by a spectator may be used solely for such spectator's personal non-commercial use, and may not be broadcast, published, or disseminated, or used for any commercial purposes without the prior written consent of the Terre Haute Torpedoes ("THT").

All participants agree to be filmed and photographed by the official photographer(s) and network(s) of THT, and allow event organizers the right use names, pictures, likenesses, and biographical information before, during, or after the period of participation in this competition sanctioned by Indiana Swimming to promote such competition.

Videotaping and photography on deck during this event is only allowed by approved USA Swimming member Coaches, Media, Webcasting staff, and THT photographer(s) in their professional capacities or meet workers assigned by THT if so designated to do so.

MEET FORMAT & ENTRIES

Format:

All events will be timed finals.

The 1650 event will be swum as an OPEN timed final event and will be awarded by age group (8 & Under, 9-10, 11-12, 13-14, and 15+). All individual 10 & Under events will be awarded by age group (8 & Under, 9-10). Open events will be scored as 15+ for the High Point Awards. All relays will be conducted on a timed final basis.

THT reserves the right to limit any event to adhere to the 4-hour rule to maintain a reasonable timeline. Refunds will be given for those events that are limited.

Flyover starts may be used at the discretion of the Meet Referee.

1650 Freestyle event swimmers must provide their own timer and lap counter. This event will be swum fastest to slowest, alternating girls and boys.

A courtesy rest shall be given for swimmers in consecutive events. It is the responsibility of the coach or swimmer to notify the Meet Referee of a swimmer's situation PRIOR to the swimmer's first event regarding the courtesy.

Meet Schedule: Terre Haute, IN. observes Eastern Standard Time (EST). All times listed in this document are local time. Warm-up/start times may be adjusted based on entries for the meet. THT will inform all teams entered if changes are made.

Meet Entry Limits:

The meet will be limited to the first 400 swimmers entered. Please be aware that if COVID-19 restrictions are placed upon the aquatic center by the Vigo County School Corporation, entries will be taken on a first come, first serve basis.

Entry Fees:

\$9.50 entry fee per athlete (includes a \$7.50 facility fee and a \$2 ISI surcharge)

\$5 per individual event

\$8 per relay event/\$2 per swimmer

If permitted, deck entries will be double the applicable event fee. Please make checks payable to THT. All entry fees must be received on the first day of the event.

IE Entry Limits: Individual events will be limited to four (4) per day.

Relay Entry Limits: Relay events will be limited to one (1) relay event per day.

Any swimmer exceeding the limit will be entered in events each day until the limit is met; events thereafter will be dropped. Friday evening events may be limited to the top 30 swimmers in each event. The only exception is the 1650, which may be limited to the top 30 swimmers, men and women combined. Those teams whose swimmers do not make the cut-off time will receive a refund for entry fees for that event. A psych sheet for Friday evening's events will be sent to the contact listed on the team summary report and posted to the event page at www.terrehautetorpedoes.com prior to event.

Entry Submission:

Entries deadline is October 15, 2021. Entries will be accepted from a Meet Manager file and should be emailed to entries@terrehautetorpedoes.com prior to the submission deadline. Deck entries may be permitted if the meet is not full. Late entries will only be accepted if the meet is not full.

Scoring: The top 10 finishers in each event will score.

Individual scoring: 11-9-8-7-6-5-4-3-2-1 Relay scoring: 22-18-16-14-12-10-8-6-4-2

Eligibility: Swimmers must be registered with USA Swimming. Age as of October 29, 2021 will determine the swimmers age for the entire meet. Indiana Swimming does not process on-site registrations.

For USMS swimmers, age as of October 31, 2021 will determine the swimmer's age for the entire meet.

Positive Check-In: In all individual events other than the 1650, the swimmer is assumed to be swimming unless

he/she has been scratched. Entrants in the 1650 freestyle must check-in and confirm their

intention to compete before the appropriate scratch deadline in order to be seeded.

Coach Scratch Box Responsibility:

ALL scratches for individual events must be made at the Head Table by:

Saturday and Sunday morning sessions-7:15 AM EST
Saturday and Sunday afternoon sessions-11:45 AM EST

Clerk of Course: There will be a Clerk of Course located behind the diving boards for 10 & Under events only.

All other swimmers report to the blocks for their events. It is the responsibility of the coach and swimmer to appear at the correct starting platform ready to swim in time for the start of his/her heat. Seeded heat sheets will be posted throughout the pool prior to the start of each session and available to coaches prior to start of each session.

Awards: High point awards: top male and top female in each age group (8 & Under, 9-10, 11-12, 13-14,

and 15+). Team trophies will be awarded to the top two visiting teams.

Individual events: 1st-3rd place will receive medals

4th-8th place will receive ribbons

Relay events : 1st-3rd place will receive ribbons

Officials: THT welcomes any officials with current certification to officiate at the Halloween Splash.

Please indicate how many officials from your team will be present for the meet on your team's entry form or have interested officials contact THT's meet referee with session(s) he/she would be willing to work at meetreferee@terrehautetorpedoes.com. Interested officials may also contact the meet referee at the meet upon arrival. Officials' meetings will be held one half hour

prior to the start of each session.

Tickets will remain on sale until the event is sold out. The doors will open for spectators half an hour before the start time of each session. THT admissions volunteers will not be able to process admission purchase(s) at the venue. It is encouraged to purchase session admission prior to the event to ensure your seat(s). RULES, POLICIES, AND RISK ASSUMPTION

Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP"), will govern this meet. Any swimmer entered in the meet, must be certified by a USA Swimming-member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Swimmer(s) must be registered with USA Swimming to be accepted into this meet. The swimmer's age as of October 29, 2021 shall determine the swimmer's age for the entire meet. Indiana Swimming does not process onsite memberships.

At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee may assist in making arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.

The competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Rule 205.10.1. All swimsuits shall be made of textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

Coaches and Officials MUST display their current USA Swimming coach credential or Deck Pass to gain deck access. The meet referee and/or meet director reserves the right to ask for coach credential or Deck Pass and/or deny deck access if coach does not comply or card is no longer valid/current.

The use of audio or visual recording devices, including a cell phone, is not permitted in any changing area, restrooms, or locker rooms. Deck changes are prohibited. It is understood and agreed that USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.

COVID Risk Assumption

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and individuals with underlying medical conditions are especially vulnerable.

USA Swimming, Inc., cannot prevent you (or your child(ren)) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming sanctioned events. It is not possible to protect against the presence of the disease. Therefore, if you choose to participate in a USA Swimming sanctioned event, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

By attending or participating in this competition, you voluntarily assume all risks associated with exposure to covid-19 and forever release and hold harmless USA swimming and Indiana swimming and each of their officers, directors, agents, employees or other representatives from any liability or claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claims you may have to seek damages, whether known or unknown, foreseen or unforeseen, in connection with exposure, infection, and/or spread of covid-19 related to participation in this competition.

Safe Sport 360

The Minor Athlete Abuse Prevention Policy prohibits Applicable Adults (as defined) from having one-on-one interactions with minor athletes which are not within an observable and interruptible distance from another adult. Applicable Adults are required to abide by this policy in full during this meet.

Pursuant to USA Swimming Rules and Regulations and federal law, it is every member's responsibility to immediately (i.e., within 24 hours) report any incident of child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport. Reporting must occur when an individual has firsthand knowledge of misconduct or where specific and credible information has been received from a victim or knowledgeable third party. A report to the U.S. Center for SafeSport may be made via telephone at 720-531-0340 or online at www.uscenterforsafesport.org/report-a-concern. Various state laws may also require reporting to law enforcement or to a designated child protection agency.

All athletes age 18 and older must complete Athlete Protection Training in order to be a USA Swimming registered member in good standing. Any athlete who turns 18 on or after [insert date that is 30 days prior to the last date of the actual competition], who has not completed Athlete Protection Training by the first day of competition, will be prohibited from participating in the competition until such time as all membership requirements are completed. Times achieved by an athlete who turns age 18 on or after [insert same date], who competes in this USA Swimming sanctioned event without completing this membership requirement, will NOT count for qualification or recognition. This includes participation as a member of a relay.

Meet will be pre-seeded and deck entries are not permitted. Heat sheets will be available at no additional cost on the Terre Haute Torpedoes website. QR codes will be posted around the facility for spectators to scan and be taken directly to the heat sheets on the Terre Haute Torpedoes website by using a smartphone.

COVID POLICY ADDENDUM (SAFETY PLAN)

VIGO COUNTY SCHOOL CORPORATION AQUATIC CENTER COMPETITION PLAN

Team and Meet Personnel

- 1. Only athletes, coaches, and meet officials that are registered USA Swimming members or members of a school team that are competing will be allowed on the pool deck.
- 2. Athletes will have to wear a mask when they are not competing. This includes when using any common space including the locker room, bleachers, or on the pool deck for any reason. Athletes should wear their mask to the blocks, remove the mask to compete and then replace the mask when returning to the team area or warm down pool.
- 3. Other team personnel (coaches and trainers) and meet officials will remain masked at all times.
- 4. Any athlete or meet staff experiencing any symptoms of a fever (100.4 or higher), recent cough, unusual fatigue, headache or have been exposed to any person who has had COVID-19 symptoms. This includes family and friends. This person should remain at home.
- 5. Swimmers that do not follow the rules will not be allowed to swim.

Spectators

- 1. Spectators may enter through the main lobby (entry # 1).
- 2. All spectators will have to be masked at all times while in the aquatic center.
- 3. Any spectator experiencing any symptoms of a fever (100,4 or higher), recent cough, unusual fatigue, headache or have been exposed to any person who has had COVID-19 symptoms. This includes family and friends. This person should remain at home.
